Old Man's Journey only accesses your storage to read in game relevant data from a resource package delivered by Google Play and to store screenshots of the game.

Google Play Games Services and Google Sign-In

We use Google Play Games Services to synchronize save games between your devices. If you don't want to synchronize save files, you don't need to sign in. To manually sign out or to sign in, we provide a Google Sign-in button in the pause menu. We don't access any data of your Google account. The play experience will always be the same, even if you don't sign-in to Google!

Unity

We have recently found out that Unity 5.6.4, which we used to build Old Man's Journey for Android, implements an interface to request a device's Android Device ID and the Advertising ID even though this was never enabled by us. This is a bug and sadly it won't be fixed in this old Unity version anymore. We don't use this interface or these IDs in Old Man's Journey whatsoever and never access them.'

Broken Rules Privacy Notice

We Broken Rules Interactive Media GmbH, Museumsplatz 1, Stiege 1, Top 2, 1070 Vienna ("**Broken Rules**" or "**we**" / "**us**") as the data controller take the protection of your personal very seriously. Therefore, we handle your personal data as confidential information and in compliance with the statutory data protection regulations as well as this Privacy Notice.

This Privacy Notice provides you with information on how we process your personal data when you use Old Man's Journey on Google Play ("**Game**").

1. What kind of your data we process

You are under no obligations to provide Broken Rules with the data we ask you for. However, if you do not provide your personal data, you will not be able to use Game and/or the features we provide. Should the provision of your personal data be mandatory by law, we will inform you separately thereof.

In order to provide you with our Game to its full extent, we will collect the categories of personal data set out below:

Use our Game:

When you use our Game, we may automatically collect your:

- **game data** such as game progress (i.e. which level you have reached), achievements (also known as trophies), completed events, saves of your game progress, virtual currency and statistics including the playtime or the use of the various features as well as the data associated with any bugs and malfunctions,
- **device data** and **technical data** such as device type, operating system, network connection type, screen resolution, device language, country, location and in case you use our Game via a mobile device your mobile carrier and/or Internet service provider; and
- **user preferences and settings**, such as game language, settings regarding in-game sound and music as well as auto save functions.

2. Purposes of processing your data

We will process your personal data set out above for the purpose of:

- a. making our Game available;
- b. internal reportings.

3. Legal bases of the processing

We process the categories of your personal data listed above on the following legal bases under the General Data Protection Regulation ("**GDPR**"):

- The performance of the *contract* we have concluded with you or the necessity to take steps at your request prior to entering into such an agreement, insofar as it is necessary (Article 6(1)(b) GDPR); or
- We process some the categories of personal data set out under point 1 on the basis of our *overriding legitimate interest* according to Article 6(1)(f) GDPR to provide you the best possible user experience, such as to ensure the security of our Game as set out under Point 2 above; or
- The necessity to comply with *legal obligations* to which we are subject (Article 6(1)(c) GDPR).

4. Age Limits

We do not knowingly collect or ask for any personal information from children. In case you can't confirm full legal capacity (fourteen), please do not provide us with any data about yourself, including name, address or email address.

If you wish that we delete data of individuals under the age of fourteen, please contact us at our contact information set out under point 8 below.

5. Transfer of your personal data

To achieve the purposes set out above, we will transfer your personal data to the following categories of recipients:

If you are playing our Game on a device with Android mobile operating system which has access to Google's Play Games Services, your Game data may be synced via the Play Games Services. Play Games Services may also track your personal data in regards with the Play Games Services and the usage of Play Games Services services.

We have no access to your data stored in the Play Games Services, but you can request to delete collected data in Android settings. Under "Play Games," go to "Profile Settings". Thereafter, we will retain your personal data (i) as long as required under statutory retention obligations or (ii) as long as potential legal claims, where personal data is needed to raise or defend against the claim, are not yet time-barred.

7. Your rights in connection with your personal data

Under applicable law, you have the right to (under the conditions set out in applicable law):

- obtain confirmation as to whether and what kind of personal data we store about you and to request copies of such data;
- request rectification or erasure of your personal data;
- request us to restrict the processing of your personal data;
- object to the processing of your personal data;
- withdraw any consent previously granted for the processing of your personal data (withdrawing your consent does not affect the lawfulness of processing based on your consent before your withdrawal);
- request data portability; and
- lodge a complaint with the competent supervisory authority.
