Dear Chairman Thompson and Ranking Member Scott,

We write today expressing our strong opposition to the inclusion of H.R. 4417, the Ending Agricultural Trade Suppression (EATS) Act, or any similar legislation in the 2023 Farm Bill. Modeled after former Representative Steve King's amendment, which was intensely controversial and ultimately excluded from the final 2014 and 2018 Farm Bills, the EATS Act could harm America's small farmers, threaten numerous state laws, and infringe on the fundamental rights of states to establish laws and regulations within their own borders.

Demand from consumers, food companies, and the farming community has propelled 15 states to enact public health, food safety, and humane standards for the in-state production and sale of products from egg-laying chickens, veal calves, and mother pigs. The egg industry, which chose not to fight these laws, is far along in transitioning to cage-free facilities. But at the behest of some in the pork industry, the EATS Act was introduced with the primary goal of undermining these standards – particularly California's Proposition 12, which the Supreme Court upheld in a recent decision. Unsurprisingly, the Court unanimously rejected the pork industry's primary claim that Proposition 12's ban on the sale of pork from cruelly confined animals is unconstitutional merely because it may have indirect so-called "extraterritorial" effects on out-of-state pork producers. The Court noted that, "Companies that choose to sell products in various States must normally comply with the laws of those various States."

This is not a case of California imposing its standards on other states. Producers in any state can choose not to supply another state's consumers or to segregate animals for different markets. Pork industry economists noted this in an amicus brief, writing, "Only those producers for which compliance with Proposition 12 is economically beneficial will choose to do so, while all others will continue to supply the vast majority of the North American pork market beyond California's border and face little or no economic impact." In fact, many large pork producers, including Hormel, Perdue, Tyson, and Smithfield, as well as many small farmers, have

indicated that they already can or will be able to comply with Proposition 12's standards to supply the California market. A joint amicus brief submitted by small and independent farming businesses, farm advocacy organizations including the National Sustainable Agriculture Coalition, and state farmers unions for Indiana, Iowa, Pennsylvania, Idaho, Oregon and Washington stated, "Independent farmers are willing to meet this demand, and in doing so, can access some of the wealth and power that has accumulated only for pork integrators, and redistribute it back to local communities, businesses, and families." The EATS Act would undermine this progress and devalue the investments that farmers have already made to comply with Proposition 12 and similar laws.

The EATS Act goes beyond overturning Proposition 12 to threaten many other state laws. The bill is particularly draconian in that it aims to negate state and local laws even if there is no federal standard to take their place, creating an overnight regulatory vacuum. In doing so, H.R. 4417 would drastically broaden the scope of federal preemption and impede the ability of voters and elected officials to enact laws that address local concerns.

The range of potentially impacted laws is vast and covers every state. A sample of categories that could be impacted includes measures to protect against invasive pests, prevent infectious diseases, improve food safety, address agricultural concerns such as seed standards, and promote animal welfare and consumer protection regarding puppy mills and pet food.

We believe that Congress should not usurp the power of states to regulate food and agricultural products in a manner that is responsive to local contexts. We need not agree with every law or rule adopted by each state to adhere to this core principle of federalism. The federal government should play a complementary role to the states on agriculture policy, rather than rendering them powerless. H.R. 4417, like its precursors, remains extremely controversial. We urge you to reject inclusion of this provision or anything like it in the Farm Bill.
