

All around the world, the rapid growth of digital transformation continues to transform the way we access, process, and share information.

- Close to 2.7 billion people remain unconnected to the Internet and are deprived of socioeconomic value from being online.
- The traditional guardian institutions such as libraries, archives and museums are challenged to keep pace with the rapid growth in information.
- Weak human-centered connectivity continues preventing women and girls, rural and remote communities, indigenous peoples, persons with disabilities, and other vulnerable and marginalized groups from fully accessing information and knowledge.





For UNESCO's Information for All Programme (IFAP), the issues extend beyond internet access and the affordability of devices and data packages.

IFAP acknowledges that various barriers prevent people from accessing information, including illiteracy, limited online language choices, lack of online accessibility for persons with disabilities, and unequal skills and capacities to responsibly, ethically, and safely create socio-economic value from digital information.

## **OUR PRIORITIES**



Information for Development

Harnesses the value of information in addressing development issues.



Information Literacy

Develops media and information literacy skills to empower people to seek, create, evaluate, use and disseminate information effectively.



Information Preservation

Supports the digital transformation of memory institutions such as libraries, archives, and museums.



Information Ethics

Promotes policy debates on the ethical impacts on knowledge societies of emerging communications and information technologies (AI, the Internet of Things, Blockchain, metaverse).



Information Accessibility

Encompasses issues surrounding availability, accessibility, affordability of information, and on meaningful inclusion of persons with disabilities and elderly.



Multilingualism

Promotes language vitality, diversity and multilingualism, particularly in cyberspace, as cornestones of inclusive knowledge societies.

Provides a platform for international policy discussions, cooperation and the development of guidelines for action in the area of access to information and knowledge.

Serves as an advisory body to the Director-General.

Supports Member States to develop and implement national information policy and strategy frameworks.

## IFAP GOVERNANCE STRUCTURE

#### **IFAP Intergovernmental Council**

The Programme is guided in its planning and implementation by an Intergovernmental Council, currently comprising 18 UNESCO Member States who are elected by the UNESCO General Conference.

#### **IFAP Secretariat**

The Secretariat provides operational support to the Council, Bureau members, Working Groups and National Committees in strengthening, implementing and promoting IFAP.

#### **IFAP Bureau**

The Bureau supports the work of the Council, including planning meetings and following up on decisions.
It plays a proactive role in shaping and implementing Programme's objectives.

#### IFAP Working Groups

The Working Groups represent an important linkage to the implementation of the activities and provide an opportunity for the non-members of the Bureau, as well as for Member States non-member of the Council, to contribute to IFAP objectives.

#### IFAP National Committees

The National Committees are established in all UNESCO Member States to advance the goals of IFAP. They serve as a meeting point for diverse stakeholders and facilitate the transfer of knowledge and expertise from the international to the national level.

# IFAP WORKING GROUPS INITIATIVES

## WORKING GROUP INITIATIVES

IFAP Working Groups are composed of national experts who provide their professional expertise and address a range of issues in one or more of the IFAP strategic priorities.

They also play a key role in promoting awareness of new methods, tools, events, and resources within IFAP's priority areas.

Since 2001, IFAP has attracted and implemented USD 1.7 million, allocating small grants for initiatives that contribute to building Knowledge Societies around the world.

## ARTIFICIAL INTELLIGENCE FOR INFORMATION ACCESS (AI4IA) CONFERENCE

Organized by the Information Accessibility Working Group of IFAP

- Gathered over 40 international experts to address diverse topics on information accessibility.
- Produced an innovative format: on-demand presentations, live panel discussions, podcast series, and interactive conversations to facilitate knowledge sharing on cutting-edge advancements of the AI.
- Increased awareness and understanding of the importance of respecting privacy rights and mitigating disinformation and user manipulation in Al applications.

- In July 2022, the new milestone UNESCO/IFLA Public Library Manifesto 2022, developed with the IFAP Secretariat, was endorsed by the IFAP Bureau and launched at the 87th World Library and Information Congress 2022 (WLIC) in Dublin, Ireland.
- At the national level, IFAP participated in advocacy efforts for the Manifesto. Through presentations, workshops, and webinars in countries such as Spain, Brazil, Norway, and the Czech Republic, IFAP actively promoted the Manifesto's importance and facilitated discussions on its implementation.
