

# Privacy Statement

**Scorito.com, a company with its registered address at Minervum 7092, 4817 ZK Breda, the Netherlands**, publisher of Scorito.com, has created this privacy statement in order to demonstrate their firm commitment to privacy. The following discloses the information gathering and dissemination practices for this website.

Scorito.com processes the data itself and is the legal entity responsible for processing the data. The Scorito-platform is an online gaming platform consisting of a website and mobile apps for iOS and Android. This privacy statement applies to the entire Scorito-platform.

## **Purpose of Scorito.com's processing**

Scorito.com will process your data for the purposes of operating and administering Scorito.com, to gather statistics and in supervising adherence to these terms and conditions and the Game Rules and for the specific purposes explained below.

## **Data Collected**

Scorito.com stores user data that has either been submitted to our system by you (such as account details or in-game communication), data that has been created or logged automatically by our systems (for example IP logs or game updates), as well as any manual notes that has been added by customer service or developers to record account events.

## **Information Automatically Logged**

We use your IP address to help diagnose problems with our server and to administer our Web site. IP addresses are also logged and used for security purposes, and may be used in abuse investigations or to identify cheaters within the game itself.

## **Cookies**

We do not use cookies to extract information from you, solely to simplify your visits, mainly by having cookies remember which language and specific part of the site you want to start your visit with, or to remember last login date so that we can distinguish new users from returning ones. A temporary cookie is also used to keep track of your "session". Without that temporary cookie (which is not stored after you leave the platform) you would have had to log on again on each page. You can turn off cookies in your web browser (more information about this is available at <http://www.aboutcookies.org/>). This will however make it more or less impossible to access many of the functions on our web site. Our app uses a fenced web-solution, making it impossible for third parties to collect or combine user data across multiple sites and apps or to target visitors of the app based on such data. When you follow links from Scorito.com to other web sites, these may install tracking cookies on your computer. This is beyond the control of Scorito.com. If you want more information about our policy regarding cookies, please read our cookie policy.

## **Advertisers**

We reserve the right to use coarse location and cookies for the purpose of serving and/or targeting ads, offers and other marketing messages.

No device-identifiers are used for advertising, tracking or remarketing. No personal customer data is shared with the advertising companies, unless specifically mentioned in a campaign promotion and permission from the user is acquired for this specific purpose.

## **Registration Forms**

Our site's registration form requires users to give us contact information (like their name, e-mail, and country).

Contact information from the registration forms is used to get in touch with the customer when necessary. It is in the users' interest to submit truthful information, as this is also used to verify the user's right to his or her account.

The customer's e-mail address is used to send an e-mail verification message, Scorito.com newsletters and event information letters (this can be opted out from), password reminders upon request, inactivity reminders, subscription expiration reminders, order confirmations, and information about changes in the terms of use.

Demographic and profile data is also collected at our site. This information is solely used for own purposes on an aggregate basis.

### **Order Forms**

Our site uses an order form for customers to request information, products, and services. We collect contact information (like their e-mail address), and financial information (like their account or credit card numbers).

Contact information from the order forms is used to get in touch with the visitor when necessary. Financial information that is collected is used to bill the user for products and services.

### **Surveys**

Our occasional voluntary online surveys ask visitors for demographic information (like zip code, age, or income level).

Contact information from the surveys is used to get in touch with the visitor when necessary.

Demographic and profile data can only be collected with permission. This information is solely used for internal purposes, collected on an aggregate basis and won't be shared with third parties.

### **Special Relationships**

Scorito.com will not share customer data with outside companies or sites, even if we have a special relationship with them. Sponsors, business partners, co-branded sites or content providers may get the opportunity to offer products and services to you within the Scorito.com web site, but we will ask you before passing on any of your personal information to other parties. The only exception is if another company needs the data for the operation of the service and they agree to adhere to our privacy policy or if Scorito.com would transfer substantially all of its assets relating to the game to another company.

### **Uploaded Public Information**

If you upload pictures of yourself, Scorito.com will consider your uploading as your express consent to the use of your picture. If pictures would include pictures of your friends or other third parties, you must ensure that such persons have consented to the publishing of the picture before uploading it.

### **Other In-Game Information**

All other information that you directly or indirectly create or access within Scorito.com is considered to be in-game information and may be accessed and used by us for the operation of the game, including investigations into cheating, fraud or criminal activities. Barring a court order, we will not share such information with third parties other than the police, our system administrators, our legal representatives and companies that develop or operate the game and have agreed to adhere to our privacy policy.

### **Security**

This site has security measures in place to protect the loss, misuse, and alteration of the information under our control. These include firewalls, physical security and password protection.

### **Opt-Out**

You can choose to terminate your Scorito.com account at any time by contacting us, or under My Scorito > My account > Delete my account. E-mail messages may be sent to all registered users. You can opt out from receiving most messages only by terminating the account. You can opt out from The Scorito.com Newsletters under My Scorito > My account > Communication settings.
