Recipients, transfers and retention period

The information related to your account deletion request is intended for :

- internal employees of our company (CHARGEMAP),
- our host, whose contact details are listed in our legal notices
- if necessary, the general services (administrative, accounting, legal) of our parent company (BRAKSON).

The information related to your request for account deletion will not be transferred outside the EuropeanUnion.

We will be likely to keep the information related to your request for account deletion for a maximum of three years after your last visit to our network. At the end of this period, unless you renew your agreement, your billing data will also be subject to intermediate archiving up to the tenth year after your purchase/subscription date, in accordance with article L123-22 of the French Commercial Code to which our company is subject.

Chargemap Pass badge use

We link your badge number to your user account. Then, when you use your Chargemap Pass badge to recharge your vehicle at a charging station managed by one of our partner network operators, we transmit this number to them to authenticate you and authorize you to use the station. Your data may also be communicated to the owners of the Chargemap-compatible charging stations you use, for information, statistical and corrective purposes. Finally, once your charging session has been processed and invoiced we proceed to the intermediate (and mandatory) archiving of your billing data. The categories of data processed in this context are :

- data relating to the management of Chargemap Pass user badges (badge number, time stamp)
- data relating to the terminal used and its use (location, charging session characteristics)
- technical data (electrical charging characteristics)

- data relating to your user account (surname, first name, e-mail address, bank details entered, note and comment given to a charging session, pseudonym and vehicle reference if you have authorized them to be made public, etc.).

Use of the badge is free, but subject to your acceptance of our general terms and conditions of service, which can be accessed at <u>https://chargemap.com/about/cgv</u>.

Archiving your billing data is a legal obligation.

Except for professional users or Chargemap Business offers, use of the Chargemap Pass badge is strictly personal and reserved for adults.

Your rights

You have the right to access, restrict and, if necessary, rectify or delete data concerning you. If you use the Chargemap Pass at a terminal of one of our partner operators located outside the European Union, data concerning you will be processed in the territory concerned by that operator. The data in question will not allow your direct identification.

We will keep your badge number for a maximum of three years after termination of your contractual relationship with our company. At the end of this period, unless your agreement is renewed, your information will be deleted from our active databases, with the exception of your billing data, which will be archived until the tenth year following the date of your subscription to our general terms of service, in accordance with article L123-22 of the French Code de Commerce, to which our company is subject.
