Purpose and legality

C & W will only process the necessary personal data in the context of executing an agreement (eg a purchase), a legitimate interest (eg direct marketing) or according to the legal provisions (eg processing data own employees).

It goes without saying that C & W securely protects all data. As a result, we have taken the necessary technical and organizational measures: C & W provides, among other things, the necessary physical safeguards, regular updates of hardware and software, adequate password management, secure internet connections and anti-virus software used to achieve this.

The personal data processed by C & W will not be passed on to third parties, unless the transfer is part of an agreement to be performed (eg direct delivery / service, licenses, subcontracting). This third party must process the personal data supplied to him in accordance with the GDPR legislation (eg do not use it for his own purposes, secure this data adequately).

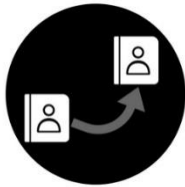
