Known limitations for the 'FLWP' website:

- 1. some pages have poor colour contrast.
- 2. some functionality is not accessible using only a keyboard.
- 3. some heading elements are not used consistently.
- 4. many labels are not correctly connected with their corresponding form fields.
- 5. some buttons and/or links don't have readable text.
