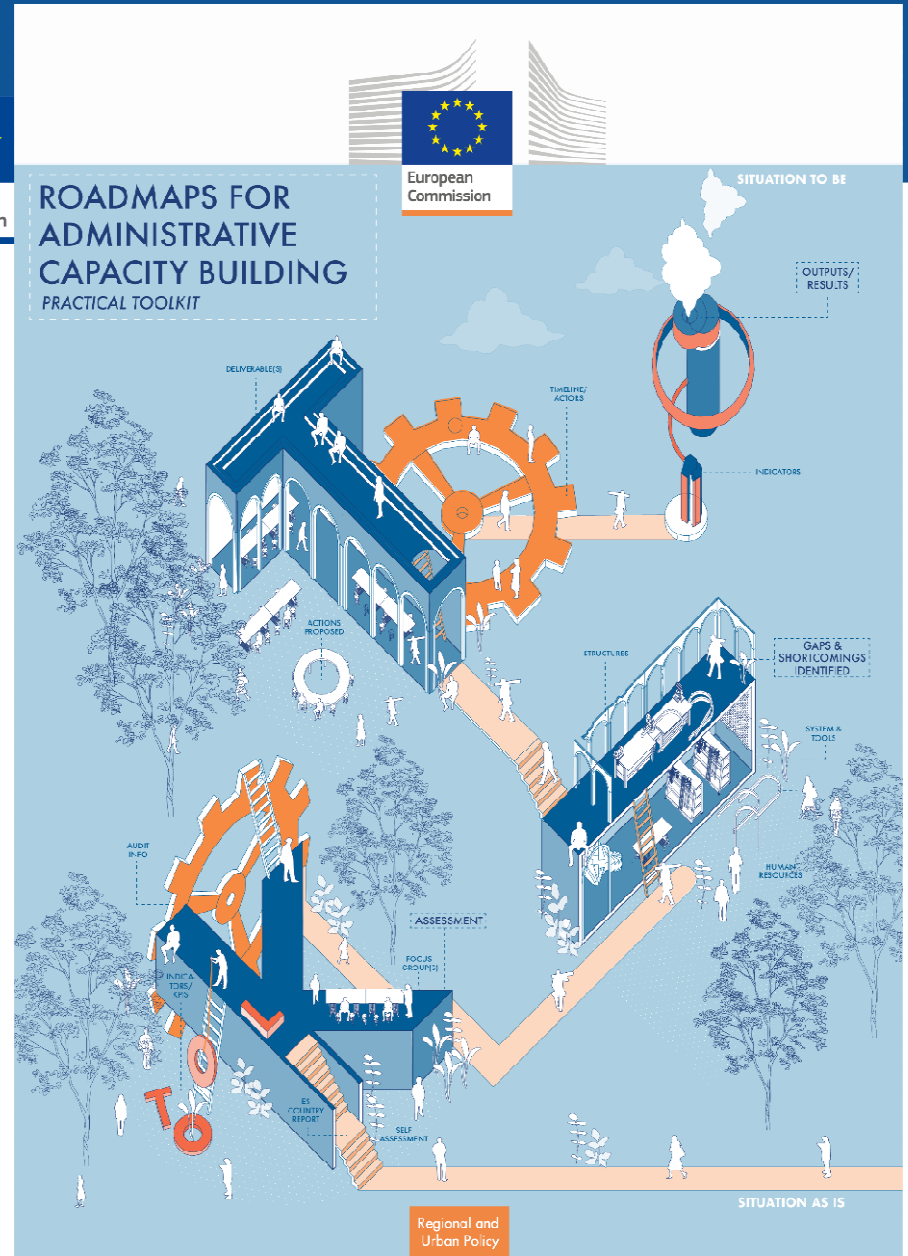


The toolkit is designed to provide inspiration for MS seeking to develop roadmaps for ACB
