Introduction

Information We Collect

Personal Information:

When you use Naiss, we may collect certain personal information provided by you, such as your name, email address, and profile picture. This information is collected when you choose to log in or create an account using Apple or Facebook authentication.

Use of Information

Providing and Improving Naiss:

Children's Privacy

Naiss is not intended for use by children under the age of 13. We do not knowingly collect personal information from children under 13. If we become aware that we have collected personal information from a child under 13, we will take steps to remove the information from our systems.

Changes to this Privacy Policy

We may update this Privacy Policy from time to time. Any changes will be effective immediately upon posting the revised policy on Naiss. We encourage you to review this Privacy Policy periodically for any updates.

Account Deletion

We value your privacy and provide you with full control over your account on our platform. If you ever decide to delete your account, we have made the process simple and accessible.

To delete your account, follow these steps:
