B.1. Describe your organization's contribution to strengthening **institutional and human capacities** for safeguarding intangible cultural heritage.

THAAP since its inception in 2006, has been actively involved in the ICH sector, at the level of capacity building and safeguarding. It has focused on transmittal of cultural knowledge working closely with tradition bearers and youth, both at the community level and through programs organized in higher education institutions and schools. Its major contribution has been in linking Tradition Bearers to educational institutions and developing pedagogies to create a nexus

between traditional and contemporary knowledge. THAAP formalized its Culture and Development Program by establishing a subset in 2010, through which several safeguarding activities & projects have been organized in ICH domains (traditional art and craft, performing arts oral folklore, medicinal practices). THAAP's, NPO platform has experts and practitioners working for development and culture programs, a resource which is offered to institutions and organizations, for capacity building and for developing Safeguarding Programs at the grass root and government level. and organizations.

THAAP developed the CBI form, which received concurrence of all provincial and state governments and was formally adopted. THAAP carried out CBI capacity building workshops for state institutions, NGO sector and other stakeholders. It carried out the first CBI of ICH in Pakistan, in collaboration with government and the local Kalasha communities, the smallest religious minority of Pakistan. Among the 49 ICH elements inventoried, one was inscribed on the Unesco USL in 2018. THAAP also developed the National Guidelines for Integrating ICH in the School System in collaboration with stakeholders, which was also adopted by the national and provincial governments.

B.2. Describe your organization's participation in activities related to the **transmission** of **and education** for intangible cultural heritage. Explain, in particular, how your organization cooperates with communities, groups and, where relevant, individuals.

THAAP's youth program aims to engage youth in safeguarding heritage and promotes intergenerational transfer of cultural knowledge in schools through collaboration with Intangible Culture tradition bearers, scholars and experts. THAAP's forte is engaging stakeholders in innovative and creative ways, such as heritage entrepreneurship, to further its prime mission of safeguarding of cultural assets through sustainable community engagement.

While THAAP has been engaged since 2007 in partnership with UNESCO over several projects. In (2017-18) THAAP participated in the mapping component of Korean funded, UNESCO project, "Community Involvement for the World Heritage Conservation and Sustainable Development". This involved mapping of the extant and endangered traditional Building Crafts of the Punjab, concentrating on the areas of Multan, Bahawalpur, and Lahore. Followed by the 2nd Stage of the Project in which the THAAP worked with the community of stakeholders, craft person, architects' designers to develop ways and means to enhance community engagement heritage sites. This work also focused on developing with mainstreaming traditional ICH knowledge in Higher Education. It also focused on identification and inventorying of Tangible and Intangible Cultural Asset, Preparation of Resource Kits and other material, identification of informed community elders and tradition and knowledge bearers. Further the Project targeted engaging communities, in particular the youth, and strengthening their role in management and protection of the heritage. This was achieved through the capacity building and engagement of key stakeholders such as youth, school children, teachers, community living near heritage sites and general awareness raising.

THAAP specializes in creating awareness and ownership of communities and individuals towards their cultural heritage assets which is anchored in exploring these assets to enhance livelihood and thus the economic wellbeing of communities. THAAP's work in cultural industries has established a sizeable network of artisans through its women empowerment/entrepreneur and livelihood projects in South Punjab. THAAP was set up for purposes of working within culture

and heritage sectors, to strengthen the nexus between culture and sustainable development and safeguarding communities' inalienable rights to their culture, particularly the intangible aspects of the Cultural Heritage. The organization endeavours to promote and create an appreciation of cultural diversity as a means towards harmony and peace amongst communities.

At THAAP the focus is on a) strengthening the skills of its in house members/staff working on ICH related areas; b) developing methodologies for integrating participatory approaches and c) introducing ethnic, religious, spiritual and age-related diversities in their activities.

THAAP documents ICH through research, in-depth interviews, observation, informal communication, and photo & video documentation. Then, through participatory approach and direct collaboration with ICH communities, THAAP identifies and defines ICH elements through community-based inventorying with prior consent of the ICH communities.

In order to make community-based inventorying possible, THAAP also conducts consultations, capacity building and awareness raising workshops for ICH communities on the 2003 Convention, discusses communities' rights and current risks and challenges in practicing their ICH.

THAAP's research dessimination forum of the Annual Conference, Talks, seminars and its Journal provides a platform for researchers, practictioners and scholars to share, present and publish their work. THAAP has a number of books to its credit and an Annual Journal since 2012

THAAP has been actively pursuing impact at the policy level and creating awareness towards critical issues which hamper the statutory and institutional support for a people cantered inclusive framework to support ICH. The struggle has received some success but much more needs to be done. THAAP's extensive work since 2010 in "Integrating ICH in education and learning" has made some difference in the private school system but the government has yet unable to develop a framework for education and culture departments to work together to develop an Action Plan, despite the enthusiasm, efforts are needed for adoption of the "National Guidelines for Integrating Education in the School System and Learning" (UNESCO-THAAP collaboration 2011).

THAAP's endeavour in Safeguarding Traditional Crafts, working closely with ICH communities in 7 districts in the Punjab, resulted in strengthening of the Cultural industries and entrepreneurship which had impact at the grass root level and the recognition by government, on the importance of this sector particularly in terms of bringing women in the workforce. Their support for marketing is slowly growing and beneficial. However, dependency on sporadic exhibitions is not enough. THAAP is actively trying to get more viable marketing pathways opened and standard setting means established to support this sector.

CBI methodology and its adoption country wide has been achieved by THAAP in collaboration with the State Cultural Department and the provincial counterparts. This is now in use. However, the legal framework for safeguarding ICH as a consolidated law is still under discussion.

THAAP has developed a network of artisans through its women empowerment/entrepreneur and livelihood projects in South Punjab. THAAP has established a network of about 15000 craft persons. THAAP was set up for purposes of working within culture and heritage sectors, to strengthen the nexus between culture and sustainable development and safeguarding communities' inalienable rights to their culture, particularly the tangible and intangible aspects of the Cultural Heritage. The organization endeavors to promote and create an appreciation of cultural diversity as a means towards harmony and peace amongst communities.

THAAP works in close collaboration with stakeholders, including government, non-government local organizations, tradition bearers and experts to bring together the diverse knowledge that is required for successful implementation of culture projects. THAAP engagement with local communities, scholars and the tradition bearers is a special feature

THAAP's main forte is creating awareness and ownership of communities and individuals towards their cultural heritage assets which is anchored in exploring these assets to enhance livelihood and thus the economic wellbeing of communities. THAAP's work in cultural industries has over the years established a sizeable network of artisans through its women empowerment/entrepreneur and livelihood projects in South Punjab. The organization endeavours to promote and create an appreciation of cultural diversity as a means towards harmony and peace amongst communities.

THAAP's forums for dissemination such as the talks, round tables, seminars, and the Annual Conference is a regular feature to promote the ICH through awareness and knowledge. It especially focuses on encouraging young researchers to work with seasoned experts to transmit knowledge and methodologies. The organizations work within communities is continuously evolving and growing organically with more refined and rapid methodologies in place to reach communities. THAAP has been actively pursuing awareness raising in communities in 3 provinces.

THAAP has also published books on ICH which have been well received and has created awareness and impact. Its latest book is, 'From Tsiam to the Hindukush,' which was written on the Kalasha Community. It is a THAAP UNESCO joint publication. Alongside THAAP has annual Journals.

The methodologies used for this engagement in communities varies in the face of the ground realities. THAAP avoids "one solution fits all" approach and develops the strategic goals and inventions on a case to case basic. This is accomplished within a framework of guiding principles such as people cantered approach, inclusivity with particular focus on the marginalized, the poor, the differently abled, the LBGTI+ community, social, human, environmental and economic sustainability.

The overall goal that THAAP promotes is to develop a community driven attitude and approach. Thus, strengthen communities' capacity to prioritise, plan, implement and safeguard their ICH be trained to carry forward the CBI process, intergenerational transmittal of cultural knowledge, seek opportunities for economic and social wellbeing of their communities. THAAP success stories which are examples are the Kalasha communities which have successfully pursued their goals for safeguarding their ICH with little reliance on THAAP handholding although consultations continue from time to time. The other sustainable outcome has been the CCI initiative in South Punjab where communities have developed excellent systems and networks in the region with THAAP constantly experimenting with marketing channels which can be sustainable for the long-term including attempting government to set up viable systems through public private partnerships.

THAAP has participated in the UNESCO Intergovernmental meetings at 15 COM, 16 COM and 17 COM. THAAP has also participated in regional events in South Korea, China and Paris. THAAP's CEO (Sajida Haider Vandal) has been the UNESCO 2003 Global facilitator for workshops in Sri Lanka, Brunei, Malaysia, Indonesia, China and Bangladesh. THAAP's Secretary (Meeza Ubaid) has recently been inducted as UNESCO 2003 Global Facilitator.

THAAP worked in the Kalasha Valleys from 2015 – 2019. It conducted the first ever CBI of Pakistan and during that, Suri Jagek was also Inventoried.

THAAP was involved in the preparation of the nominations on Suri Jagek. THAAP directly worked with concerned communities, carried out field research, developed the concept of the photo & video materials and together with the community members prepared the entire nomination file.

Suri Jagek is the first Independent element inscribed on the UNESCO Urgent Safeguarding List from Pakistan. It was inscribed in 2018 on 13 COM.

THAAP has been asked by the Government of the Punjab to develop a nomination dossier with the communities of chunri makers to enable the state party for present it for inscription in the next UNESCO round.
