**Requests for preparatory assistance for elaborating  
a proposal of a programme, project or activity to be selected  
as best reflecting the principles and objectives of the Convention  
(Form ICH-06)**

1. As provided in Article 18 of the Convention, States Parties may request preparatory assistance aimed at supporting the elaboration of proposals of programmes, projects and activities that the Committee may wish to select and promote as best reflecting the principles and objectives of the Convention.
2. At its second session, the General Assembly adopted the Operational Directives of the Convention (Resolution 2.GA 5) which established in its paragraphs 43 to 51 the proposal and selection procedure of these programmes, projects and activities; specified the criteria for selection in its paragraph 52; and the promotion and dissemination in its paragraphs 53 to 58. In its Resolution 2.GA 8, the General Assembly allocated the sum of USD 336,849 for preparatory assistance in the period 1 July 2008 to 31 December 2009, including assistance to prepare both proposals of programmes, projects and activities under Article 18 and nominations for the Urgent Safeguarding List.
3. The deadline by which preparatory assistance could be requested was 1 October 2008. Proposals elaborated as a result of this assistance should be submitted by 2 March 2009 for evaluation by the Committee in September 2009. The Operational Directives provide that requests for international assistance less than US\$ 25,000, including these requests for preparatory assistance, will be evaluated by the Bureau of the Committee.
4. As of the 1 October 2008 deadline, the Secretariat received five requests for preparatory assistance for elaborating a proposal of a programme, project of activity to be selected as best reflecting the principles and objectives of the Convention. The proposals, from five States Parties, total USD 30,000. After reception of the requests for preparatory assistance; the Secretariat, in conformity with the Operational Directives, assessed the completeness of the requests, asked for additional information if needed and informed the requesting State Party about the evaluation date of the request by the Bureau (20 October 2008).
5. The Bureau met on 20 October 2008 for the evaluation of two different kind of requests: requests for preparatory assistance for elaborating a nomination for inscription on the Urgent Safeguarding List and requests for preparatory assistance for elaborating a proposal of a programme, project or activity to be selected as best reflecting the principles and objectives of the Convention (Article 18).
6. With regard to the requests for preparatory assistance for elaborating a nomination for inscription on the Urgent Safeguarding List, the Bureau decided to approve all the requests and the Secretariat has informed all the States concerned accordingly.
7. With regard to the requests for preparatory assistance for elaborating a proposal of a programme, project or activity to be selected as best reflecting the principles and objectives of the Convention (Article 18), the Bureau noted that there appeared to be confusion regarding these requests, which seem not to be all aimed at preparatory assistance for Article 18. The Bureau therefore decided that it was not able to evaluate the requests, and asked the Secretariat to advise the States Parties concerned on how to revise their requests. It further requested the Secretariat to provide it with a recommendation concerning each request at its next meeting scheduled to take place in December 2008 to facilitate its decisions. All the requests are listed in the table below.

8. The Secretariat communicated to the States Parties concerned the decision of the Bureau. Mongolia (request n° 00262), Côte d'Ivoire (request n° 00291) and the Dominican Republic (request n° 00295) informed the Secretariat of the withdrawal of their requests which will be replaced at a later stage by a request for international assistance (form ICH-04).
9. The complete requests of Bolivia, Chile and Peru (multinational request n° 00177) and from Ukraine (request n° 00293) are annexed to this document in the language received by the Secretariat (English or French, the working languages of the Intergovernmental Committee) for evaluation by the Bureau, together with a recommendation, in English and French, prepared by the Secretariat, in conformity with the decision of the Bureau.
10. In conformity with the Operational Directives, the Secretariat shall communicate the decision concerning the granting of preparatory assistance for elaborating a proposal of a programme, project or activity to be selected as best reflecting the principles and objectives of the Convention to the requesting parties within two weeks following the decision.

The Bureau of the Intergovernmental may wish to adopt the following decision

<b>1. Title of the programme, project or activity:</b> Project "Aymara Cultural Universe" ("Universo Cultural Aymara")

**2. Brief description of the programme, project or activity:**

*Not to exceed 250 words*

The Aymara people, one of the oldest ethnic groups of the Andean region, live in the countries of Bolivia, Chile and Peru. Although the socio-cultural aspects of their culture still thrive, their language, traditions and customs are endangered. This process began with the Inca expansion (s. XIV-XV), continued with the Spanish conquest (s. XVI), and was accentuated with the creation of the Andean national states (s.XIX), which artificially divided a region that had hosted a single culture before. Nowadays, the process of globalization and the absence of safeguarding cultural policies within these countries constitute severe menaces to the Aymara's survival.

Bolivia, Chile and Peru, States belonging to CRESPIAL, are aware that in order to protect the Aymara culture, it is necessary to improve these people's quality of life, visualize their cultural expressions and guarantee their right to difference. Therefore, the governments of these countries have agreed on the implementation of the first safeguarding measure of the 2003 Convention: promote the identification to ensure the promotion, recovery, valorization and managing of the Aymara people's living practices and traditions.

The Project "Aymara Cultural Universe" is proposed by two States members of the 2003 Convention, and one State in process of adscription. The project encourages the development of safeguarding measures aiming at ensuring the viability of the Aymara culture. This will be achieved through the participation of concerned groups from each country, the reinforcement of living practices -especially language-, the promotion of the region's cultural diversity, and the sensibilization of local, national and international communities regarding the importance of intangible heritage.

As preparatory assistance, CRESPIAL requests a meeting of specialists on heritage so as to formulate the project to be presented before UNESCO. The meeting will enable the Regional Center to define the operational elements necessary for the regional project, which will respond to each country's needs and particularities. The project will involve Aymara communities and groups, who are expected to appropriate the safeguarding measures and participate in the suitable management of their culture. This initiative will ensure the viability of their heritage and its transmission to future generations.

The Project will promote the organization of at least one meeting with cultural managers and with selected Aymara community members. It will also encourage the strengthening of a permanent network of intangible heritage specialists, agents, managers and bearers, who will participate in the activities conducted by the Center, such as workshops, database implementation and periodical diffusion through institutional publications. CRESPIAL and the National Executive Agencies will monitor and evaluate the project permanently.

The specialists' meeting will enable CRESPIAL to elaborate the proposal of the project to be presented before the Committee. This initiative is in accordance with the objectives and principles of article 18 of the 2003 Convention.

**7. Preparatory measures to be supported financially by this request:**

In order to conduct the Aymara Cultural Universe Project, CRESPIAL has already established communication with the government representatives of Bolivia, Chile and Peru.

The preparatory assistance requested to UNESCO will allow CRESPIAL to cover the specialists' international air flight tickets and airport taxes, file-related expenses, and the file's delivery to UNESCO through a private courier.

The Aymara Project's first meeting will take place the second week of December 2008 in Cusco, city where CRESPIAL is based. The Center will assume the costs of national plane tickets Lima-Cusco-Lima, meals, lodging, work materials, diagramming, and the publication of the meeting's results. It will also cover professional, technical and logistic support up to \$20,000 American Dollars.

Bolivia, Chile and Peru will provide the work of their professionals and specialists in the integral development of the project. These countries will assume the project's implementation and expenses according to their economic possibilities. The project will be coordinated by CRESPIAL, Regional Center for the Safeguard of Intangible Heritage in Latin America, sponsored by UNESCO.

1. The project “Aymara Cultural Universe” is designed to encouraging the development of safeguarding measures aiming at ensuring the viability of the Aymara Culture. It is a multinational request proposed by Bolivia, Chile and Peru and therefore proposes the coordination of efforts for safeguarding intangible cultural heritage on the sub-regional level. The preparatory assistance will promote the organization of at least one meeting with cultural managers and with selected Aymara community members in order to elaborate a proposal to be submitted under Article 18.
2. The Bureau must evaluate whether the requested preparatory assistance is likely to result in a proposal to be submitted to the Committee of a programme, project or activity to be selected as best reflecting the principles and objectives of the Convention. The implementing organization, CRESPIAL (Regional Centre for the Safeguarding of Latin America’s Intangible Heritage), has an established record of sub-regional cooperation and has the operational capacity to implement the proposed preparatory activities. It is not necessary for the Bureau to evaluate at this time whether or not the project that might be proposed as a result of this preparatory assistance might be selected by the Committee as best reflecting the principles and objectives of the Convention, according to the criteria laid out in paragraph 52 of the Operational Directives.

**Format of application**

1. National Sorochintsy fair is the most beautiful and famous fair-exhibition and cultural activity in Ukraine which history came from the second half of XVIII century and it is an original intangible cultural heritage of Ukrainian nation and other nations settled in Ukraine. It safes national song, art, dance, life and traditional ceremony culture and it becomes the common property of millions people annually.

2. National Sorochinty fair is the largest fair-exhibition activity and unique and only one fair in the world saved from the second half of XVIII till nowadays. It is traditionally hold once a year during the five days on penultimate week of August, on the 16,2 hectare under the sky, in village Sorochinty of Myrgorod district of Poltava region in Ukraine. It is described in 1829 by genius of world literature N. V. Gogol in his tale “Sorochinskaya yarmarka”. In 2008 about 1,5 thousands participants had taken part in it (including 500 craftsmen of national works), more than 4 thousands participants of artistic groups of national music, song and dancing work and about one million guests have visited the fair. For today this activity keeps, multiplies, polularizes native traditions, culture, art of Ukrainian people, keeps live tradition in general process of urbanization and unification of Ukrainian society in its modern development conditions.

This is an original national activity assists in close friendly relationship between people, nations, develops cultural interchange, forms patience and understanding, assist in intimacy of countries and nations.

3. National Sorochitsy fair is prepared and carried out by “Sorochynskiy Yarmarok”, LTD. The Chief of the Project Svetlana Svichsheva. The organization has the status of general manager and is situated according the following address: Office 309, Frunze Street, 225, Poltava city, Ukraine, 36008.

4. National Sorochinty Fair takes place in Velikie Sorochinty village of Mirgorod district of Poltava region in Ukraine on the territory, which includes 16.2 hectares, and the fair’s influence extends to the whole territory of Ukraine. The activity has the status of national but the geographic scale of influence is international.

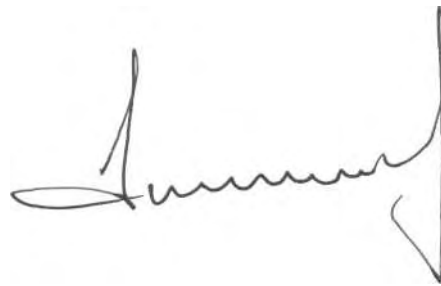

1. Request 00293 from Ukraine seeks financial assistance for the elaboration of a nomination file for the Representative List of the Intangible Cultural Heritage of Humanity. The work described in the request was completed prior to 29 September 2008, on which date the Secretariat received from Ukraine a completed nomination file requesting inscription of Sorochinskiy Yarmarok on the Representative List (inscribed as nomination 00246). Ukraine here seeks to have its expenses of video filming, photography and manuscript preparation supported retroactively by the Intangible Heritage Fund (see item 6 of form ICH-06).
2. The Operational Directives in paragraph 64 specify that “The Committee may receive, evaluate and approve requests for preparatory assistance aimed to help the elaboration of requests for inscription on the Urgent Safeguarding List referred to in Article 17 and for proposals as referred to in Article 18 (preparatory assistance)”. When the Committee adopted this paragraph, it excluded the possibility of providing funds for the elaboration of requests for inscription on the Representative List. The Secretariat informed the State Party of this limitation prior to the Bureau meeting of 20 October 2008 and again subsequent to that meeting, but the State Party wished to bring the request to the Bureau’s attention.
3. Request 00293 does not satisfy the criteria and procedures for preparatory assistance for elaborating a proposal of a programme, project or activity to be selected as best reflecting the principles and objectives of the Convention, as laid out in paragraphs 47 and 59-75 of the Operational Directives. The Bureau may wish to decline the request.
4. The Bureau may further wish to consider inviting the State Party to submit a future request for international assistance from the Intangible Heritage Fund, using form ICH-04, recalling that States Parties may request such assistance to supplement their national efforts for the following purposes, as specified in paragraph 62 of the Directives:
  - a) The safeguarding of the heritage inscribed on the Urgent Safeguarding List;



- b) The preparation of inventories in the sense of Articles 11 and 12;
- c) Support for programmes, projects and activities carried out at the national, sub-regional and regional levels aimed at the safeguarding of the intangible cultural heritage;
- d) Preparatory assistance (as described in paragraph 64).
