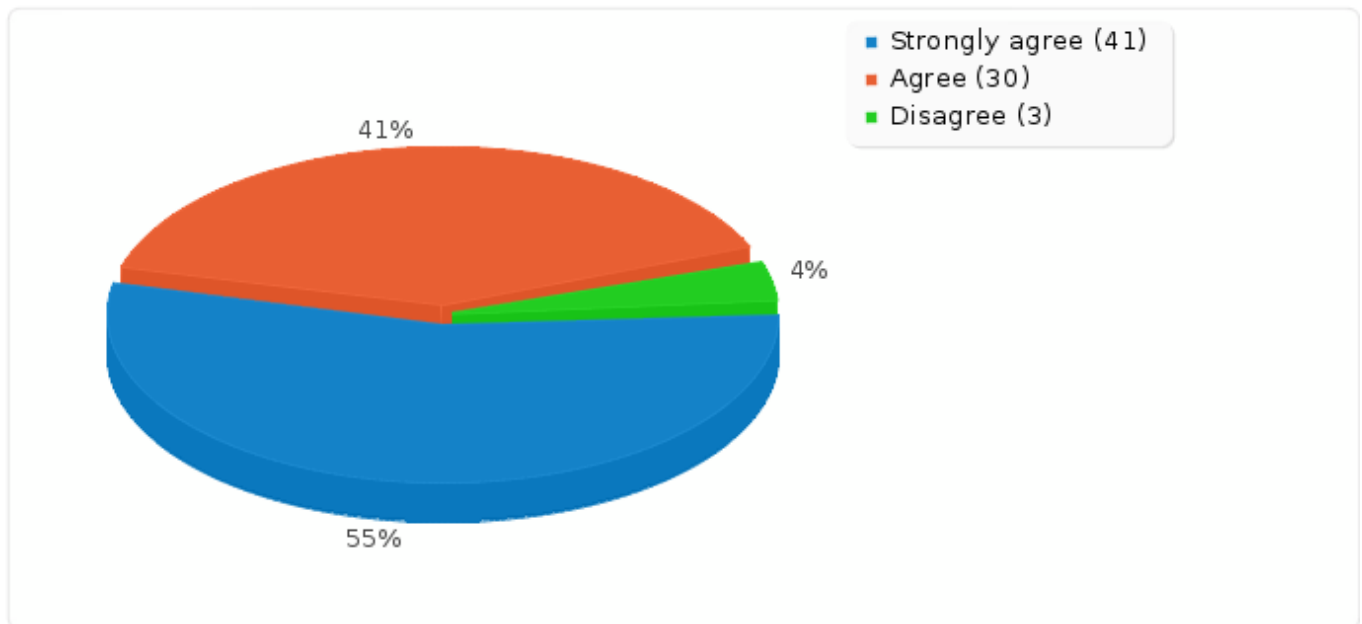

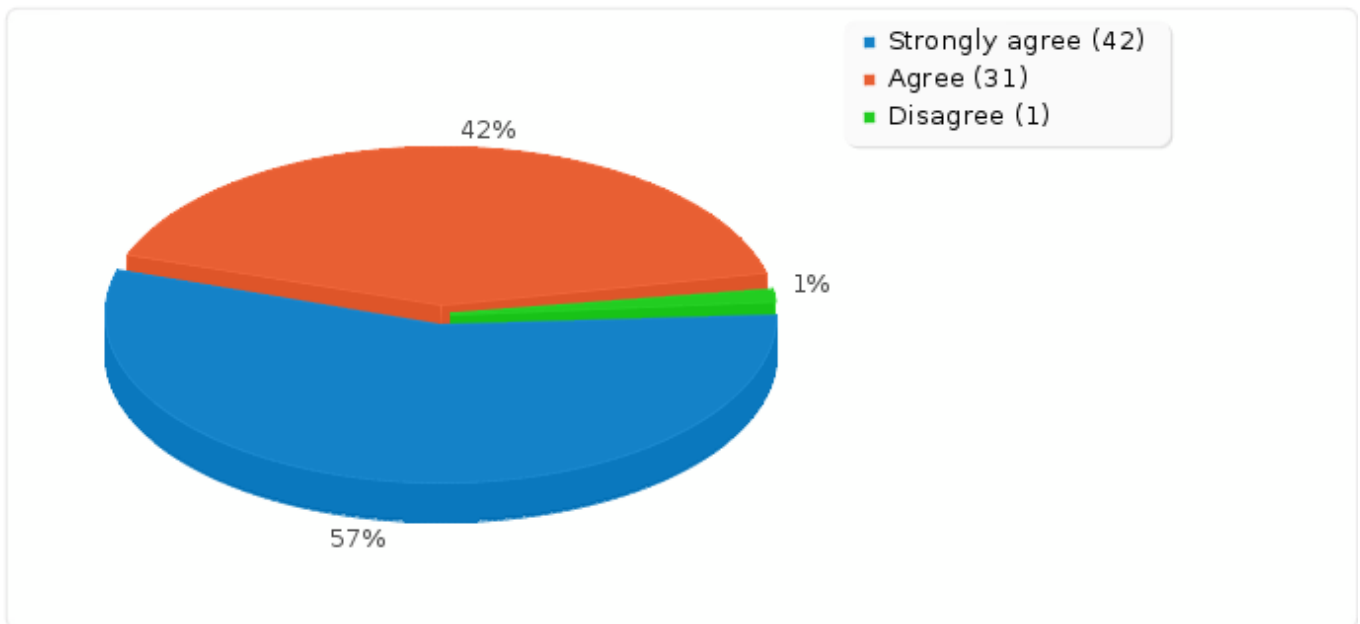

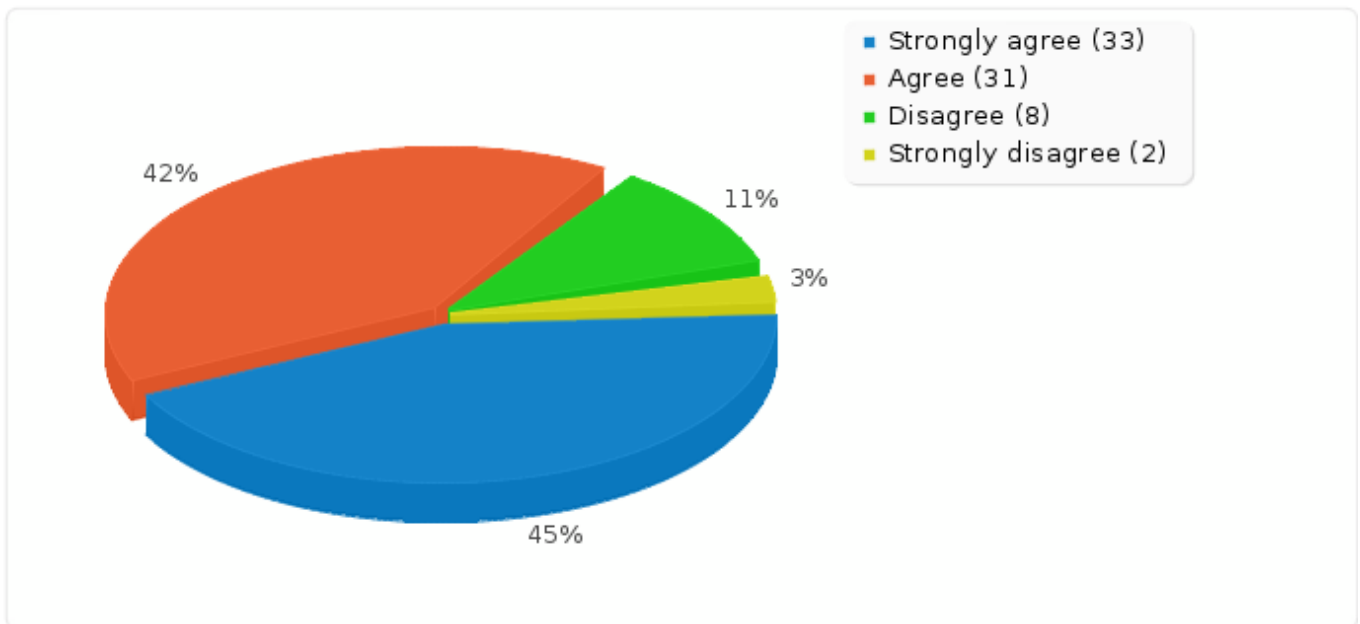

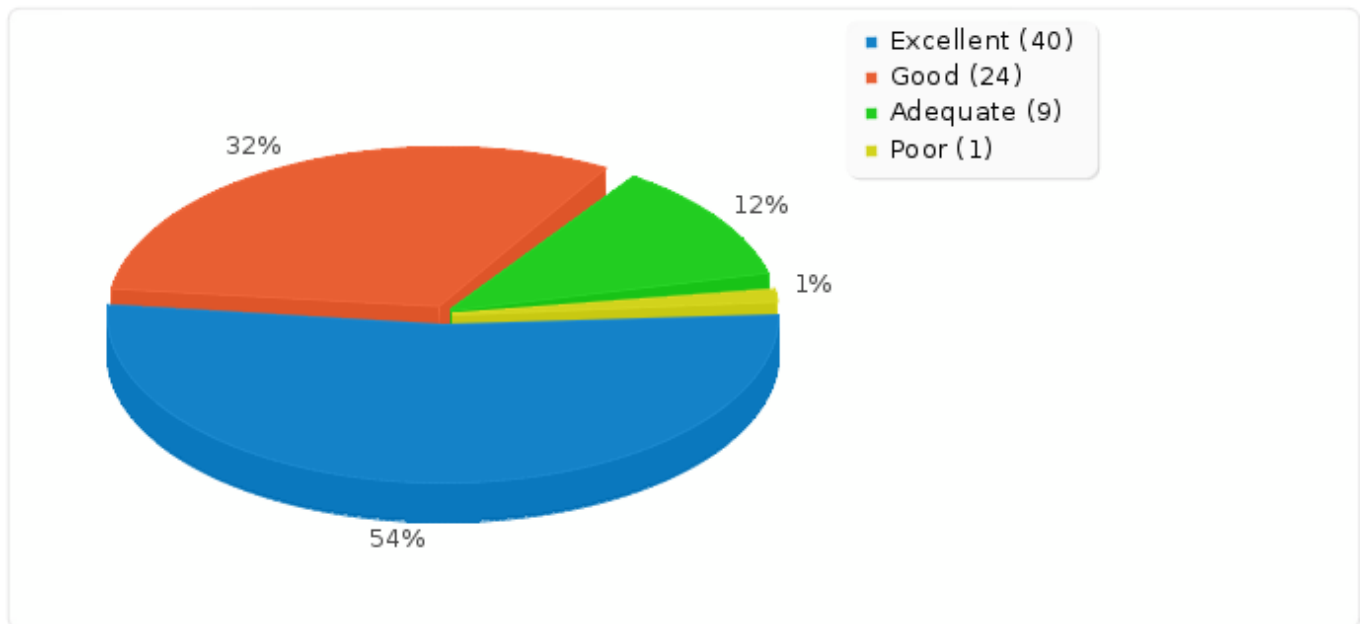

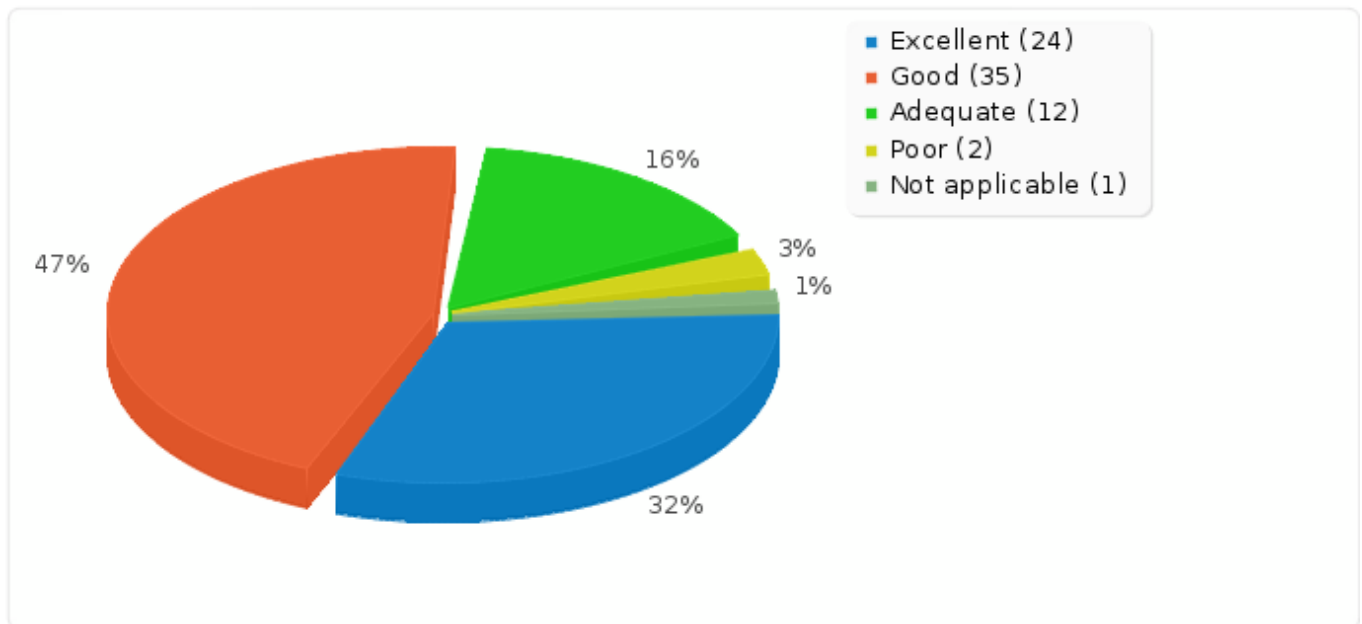

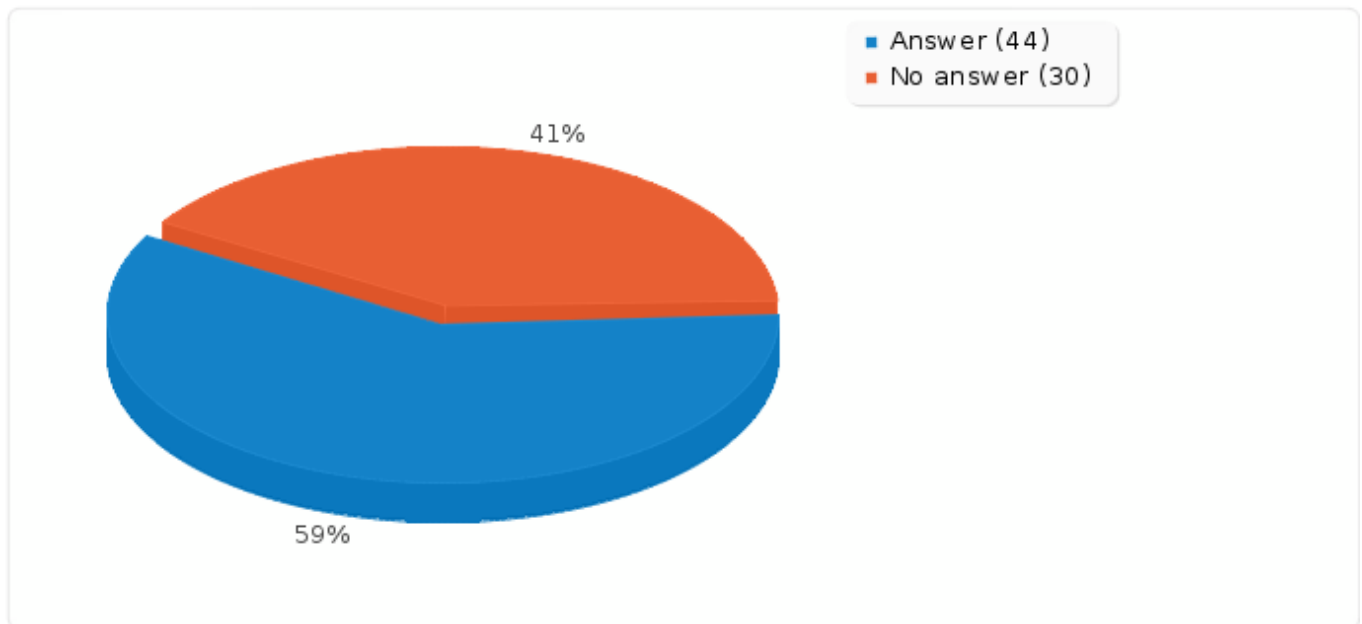

The expert or the Ambassador sits alone in the front and the support delegate sits behind, so there cannot be good communication between the two.

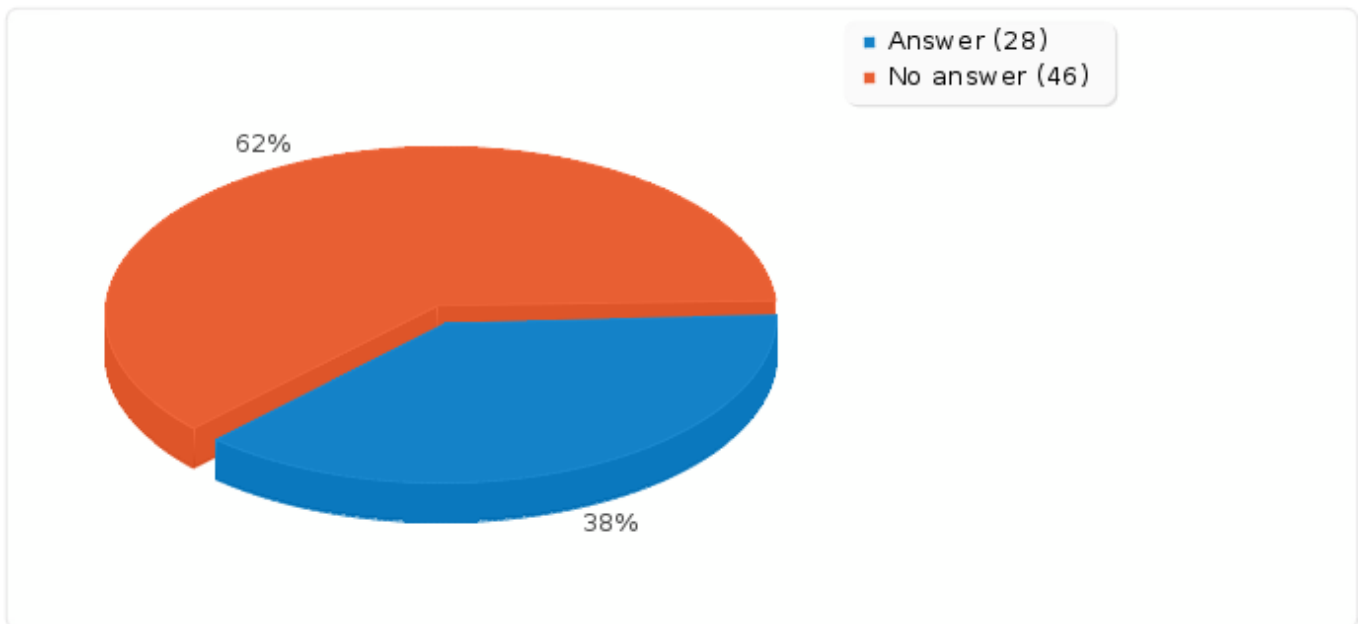
