27 The work is well organized. An important element is awareness-raising on the application of the Convention (various seminars and workshops)

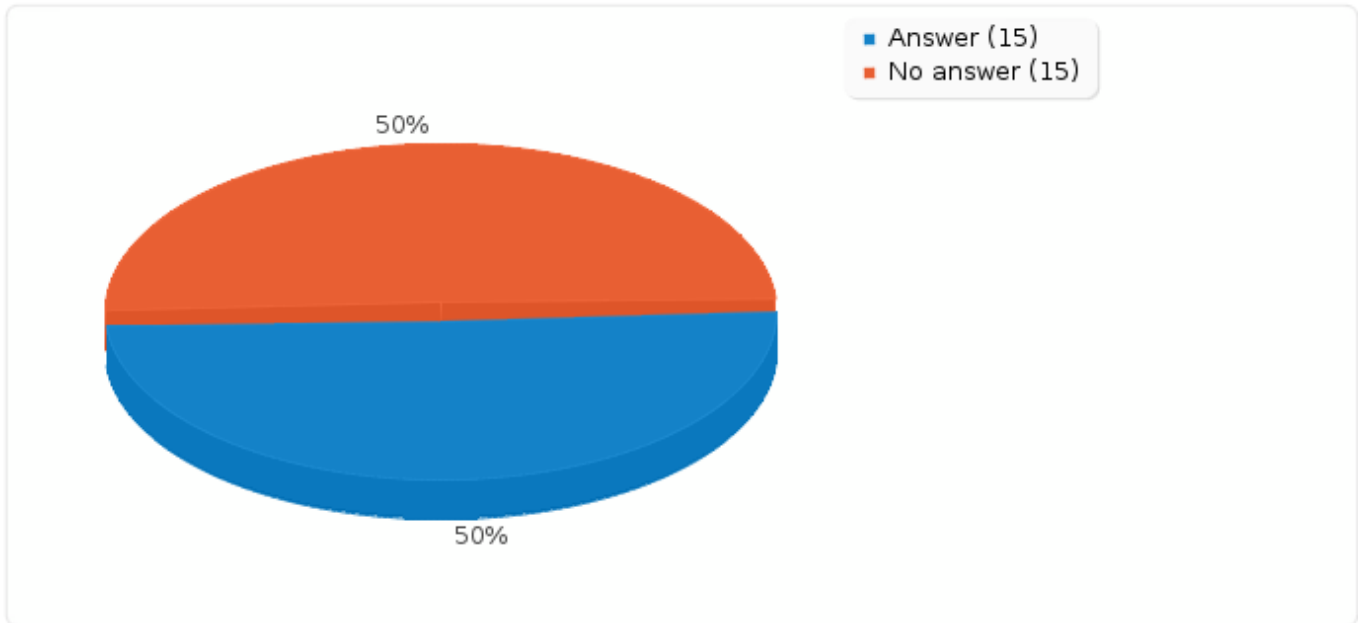

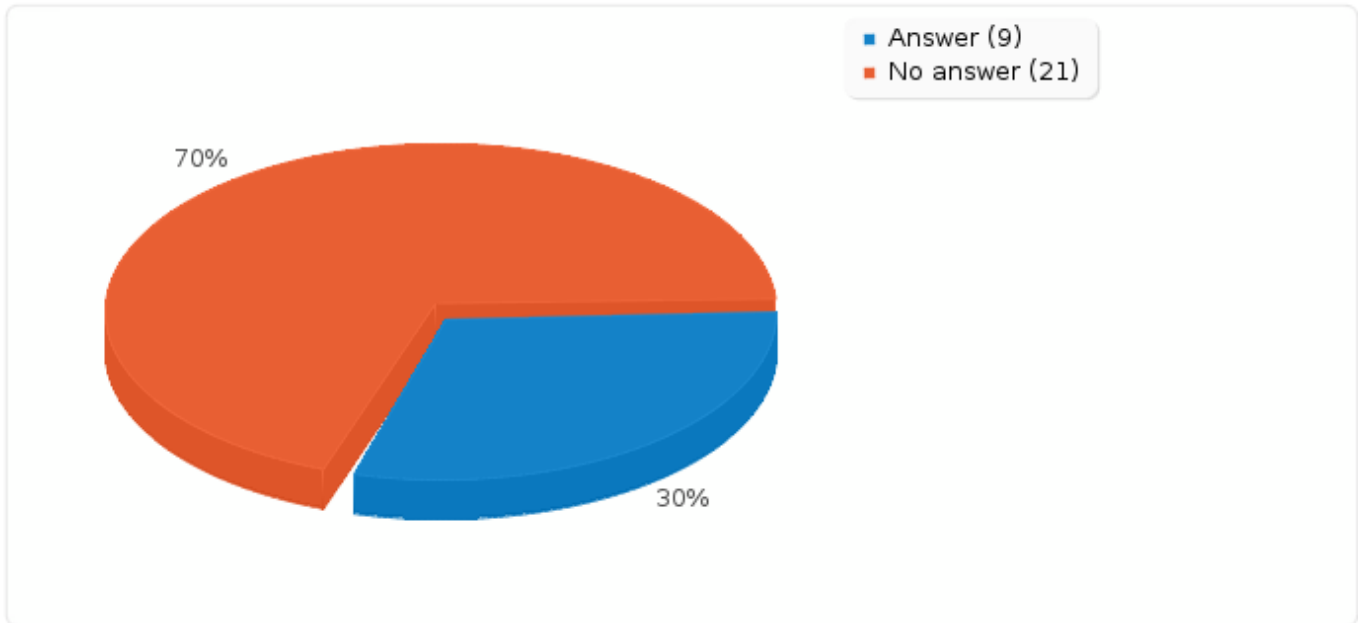
