At Taxibrouwer, accessible from www.taxibrouwer.nl, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by Taxibrouwer.nl and how we use it.

This Privacy Policy applies only to our online activities and is valid for visitors to our website with regards to the information that they shared and/or collect in Taxibrouwer.nl. Consent

By using our website, you hereby consent to our Privacy Policy and agree to its terms.

Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you register for an Account, we may ask for your contact information, including items such as name, company name, address, email address, and telephone number.

How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our website
- Improve, personalize, and expand our website
- Understand and analyze how you use our website
- Develop new products, services, features, and functionality
- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes

- Send you emails
- Find and prevent fraud

View, modify or delete data

You have the right to view, correct or delete your personal data. This you can do this yourself via the personal settings of your account. In addition, you have the right to withdraw or object to your consent to the data processing object to the processing of your personal data by our company and you have the right on data portability. This means that you can submit a request to us for the personal data that we have about you in a computer file to you or another person, organization specified by you. Do you want to exercise your right to object? and/or right to data portability or do you have other questions/comments about the data processing, please send a specified request to {email}. To be sure that the request for access has been made by you, we ask you for a copy of your to enclose proof of identity with the request. Make in this copy your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service Number (BSN) black. This is to protect your privacy. Taxibrouwer shall respond to your request as soon as possible, but in any case within four weeks. Taxibrouwer would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority. Log Files

Taxibrouwer.nl follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

Cookies and Web Beacons

Like any other website, Taxibrouwer.nl uses 'cookies'. These cookies are used to store information including visitors' preferences, and the pages on the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

CCPA Privacy Rights (Do Not Sell My Personal Information)

GDPR Data Protection Rights
