Public Register of Club Directors

Pursuant to Rule F.35.1, this document lists the Directors of each Club. It will be updated periodically. It is noted that the tables list those that fall within the definition of 'Director' in the Premier League Rules – that definition is wide and includes (but is not limited to) someone who is a Companies House director of the Club (i.e. a statutory director), but also captures those with 'Control' over the Club, holding companies of the Club and directors of those holding companies, someone exercising powers that are usually associated with the powers of a director of a company, CEOs, and 'Relevant Signatories'.

In particular it is noted that 'Relevant Signatories' are those who are 'authorised to sign on behalf of a Club a Declaration, a written contract of employment with a Player (other than an Academy Player), a transfer agreement and/or any transfer or registration form in respect of a Player (other than an Academy Player) as may be required from the League from time to time'. Those persons who are Directors by virtue of being Relevant Signatories are identified with an asterisk in the relevant tables (*).
