
BOXING ATHLETES ENGAGE IN INTEGRITY CAMPAIGN

UCI UPDATES ITS BETTING SPONSORING RULES

The Union Cycliste Internationale (UCI) recently updated its betting sponsorship rules in order to prevent any conflict of interests that might undermine the integrity and credibility of competitions. Sponsorship is prohibited with betting companies which cannot guarantee robust integrity and impartiality. The updated regulations require the sponsorship contract to explicitly prohibit the betting company from collecting insider information and/or any other information that could be used to manipulate a cycling event, and from participating in any decision of a sporting nature.
