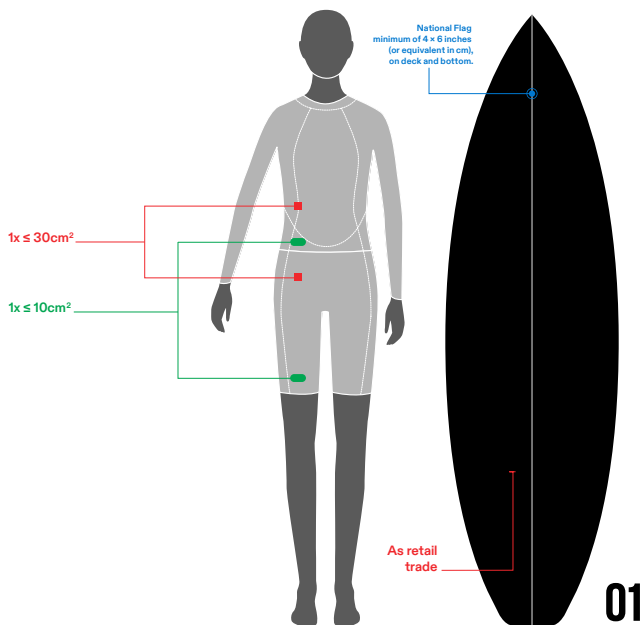

SUBMISSION PROCESS

No additional obligatory submission process required by the IF, section 14 of the General Guidelines applies.

01 MEN ATHLETE FRONT

Identification of the Manufacturer

Clothing

- Bathing suit top | Brief/Bathing suit bottom | Boardshort | Tank Top/T-Shirt/ Long-sleeve top | Wetsuit top | Jacket/ Coat/Windbreaker/Sweatshirt | Shorts/Skirts | Pants | Bathrobe

One *Identification of the Manufacturer* [■] per clothing item will be permitted, to a maximum size of 30cm².

One *Identification of the Manufacturer* will be permitted on Zippers and Buttons and should appear in the same color as the concerned item (i.e. tone on tone), as long as such identifications are deemed not conspicuous by the IOC.

- One-piece wetsuit | One-piece bathing suit

Where one-piece wetsuits/bathing suits are used in competition, one *Identification of the Manufacturer* shall be permitted above the waist and below the waist, in accordance with the maximum size noted above, however these identifications shall not be placed immediately adjacent to each other.

Sport Equipment

- Surfboard | Fins | Leash | Traction Pad | Helmet

The *Identification of the Manufacturer* may be carried as generally used on products sold through the retail trade during the period of 6 months prior to the Games.

Accessories

- Wetsuit Booties/Gloves

One *Identification of the Manufacturer* per item will be permitted, to a maximum size of 10cm².

- Hat/Visors/Headgear/Wetsuits/Hood

One *Identification of the Manufacturer* per item will be permitted, to a maximum size of 10cm²; or two *Identifications of the Manufacturer* per accessory item will be permitted, to a maximum size of 5 cm² each, placed above each ear.

- Socks

One *Identification of the Manufacturer* per accessory item will be permitted, to a maximum size of 10cm².

- Therapeutic support braces for wrist/ knee/elbow/ankle

One *Identification of the Manufacturer* per item will be permitted, to a maximum size of 6cm².

- Eyewear

May carry the *Identification of the Manufacturer* as generally used on products sold through the retail trade during the period of 6 months or more prior to the Games, with the Identifications permitted on the lenses so long as such identifications are engraved into the lens and is not deemed as conspicuous by the IOC.

- Bag

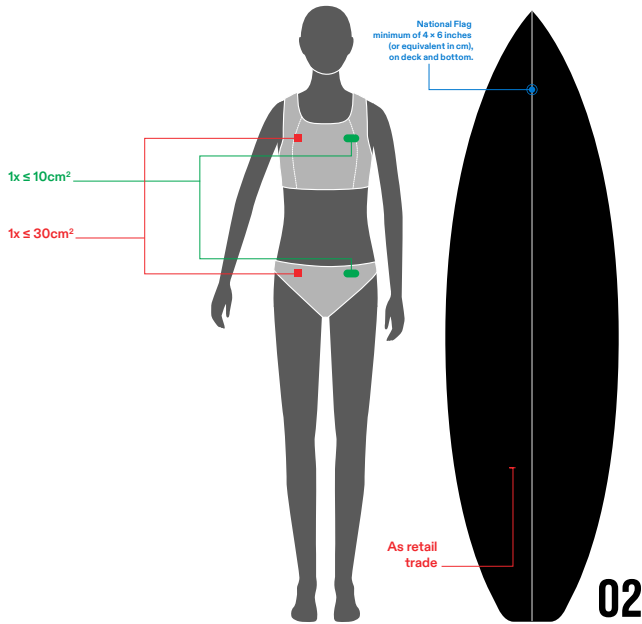
One *Identification of the Manufacturer* per item will be permitted, not greater than 10% of the surface area of the item, to a maximum size of 60cm².

Product Technology Identification

Clothing

- Bathing suit top | Brief/Bathing suit bottom | Boardshort | Tank Top/T-Shirt/Long-sleeve top | Wetsuit top | Jacket/Coat/Windbreaker/Sweatshirt | Shorts/Skirts | Pants | Bathrobe

One additional *Product Technology Identification* [■] will be permitted per clothing item with a maximum size of 10cm².

All General Principles apply unless expressly mentioned otherwise hereafter (in particular in relation to size, frequency or location). Please refer to the “Identifications on NOC Team Apparel Practical Guidelines”, and General Guidelines (released Summer 2023) to obtain the general principles of Authorised Identifications on NOC uniforms at the Olympic Games. This section provides visual illustrations regarding the placement and size of Sport Specific Implementation for any items.

- **One-piece wetsuit | One-piece bathing suit**
Where one-piece wetsuits/bathing suits are used in competition, one *Product Technology Identification* shall be permitted above the waist and below the waist, in accordance with the maximum size noted above, however these identifications shall not be placed immediately adjacent to each other.

No names of athletes allowed on items, section 05 of the General Guidelines applies

Section 07

NOC Emblems and National Identity

Two National Flag Stickers must be placed on the top 1/3 of all boards: one on the deck and one on the bottom. The National Flag sticker must measure a minimum of 4 × 6 inches (or equivalent in cm).

Identification of the Manufacturer

Clothing
