


All General Principles apply unless expressly mentioned otherwise hereafter (in particular in relation to size, frequency or location). Please refer to the "Identifications on NOC Team Apparel Practical Guidelines", and General Guidelines (released Summer 2023) to obtain the general principles of Authorised Identifications on NOC uniforms at the Olympic Games. This section provides visual illustrations regarding the placement and size of Sport Specific Implementation for any items.

SUBMISSION PROCESS

During the Games, the Paris 2024 Boxing Unit will perform uniform compliance verification during the Boxing Entries Check prior to the Boxing Technical Meeting.

Additionally, all boxers will have to go through the Equipment's Check Table in the Warm-up areas with the Official Equipment Manager checking all branding specifications on boxers' clothing.

01 ATHLETE FRONT

Identification of the Manufacturer

Clothing

Vest

One Identification of the Manufacturer [] is permitted, to be positioned at chest level, on the front right-hand side of the vest, with a maximum size of 30cm².

· Shorts | Skirt

One Identification of the Manufacturer [III] is permitted, to be positioned on the front of the right leg, with a maximum size of 30cm².

Robe

One *Identification of the Manufacturer* is permitted, to be positioned at chest level, on the front right-hand side of the robe, with a maximum size of 30cm^2 .

Tracksuit

One Identification of the Manufacturer is permitted on each item of the tracksuit, with a maximum size of $30\,\text{cm}^2$

Sport Equipment

Headguards

Paris 2024 Boxing Unit will designate one supplier for the Olympic Games and the sport equipment will be provided by OCOG.

Gloves

Paris 2024 Boxing Unit will designate one supplier for the Olympic Games and the sport equipment will be provided by OCOG.

Bandages

Paris 2024 Boxing Unit will designate one supplier for the Olympic Games and the sport equipment will be provided by OCOG.

Accessories

Towel

No *Identification of the Manufacturer* will be permitted.

Sock

One *Identification of the Manufacturer* [] per item will be permitted with a maximum size of 10cm².

Ba

One *Identification of the Manufacturer* per item will be permitted, not greater than 10% of the surface are of the item, to a maximum size of 60cm².

 Other protective equipment
 One Identification of the Manufacturer per item will be permitted with a maximum size of 6cm².

Shoes/Footwear

Shoes

All footwear items may carry the *Identification of the Manufacturer* as generally used on products sold
through the retail trade during the period of 6 months
prior to the Games.

Product Technology Identification

Clothing

Vest

One additional *Product Technology Identification*[•] will be permitted per clothing item with a maximum size of 10cm².

Shorts I Skirt

One additional *Product Technology Identification*[•] will be permitted per clothing item with a maximum size of 10cm².

Robe

One additional *Product Technology Identification* will be permitted per clothing item with a maximum size of 10cm².

Tracksuit

One additional *Product Technology Identification* will be permitted per clothing item with a maximum size of 10cm²

NOC Emblem and National Identity

Section 07

NOC Emblems and National Identity

The national flag or NOC emblem [] is permitted only in one area per vest, shorts and skirt as follows:

Vest

Maximum size of 50cm² at chest level, on the front left-hand side of the vest.

Shorts | Skirt

Maximum size of 50cm^2 on the front of the left leg.

Section 05

Third Party Identifications (athlete names)

The athlete's name (Preferred Family Name) may be included on the back of the vest.

As per Paris 2024 Boxing Unit Event Regulations.

Section 07

NOC Emblems and National Identity

The country/territory name or NOC code must appear on the back of the vest with a maximum size of 200cm².
