## C. ATHLETE ELIGIBILITY

### C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC may participate in the Olympic Games Paris 2024.

### C.2. Age requirements

To be eligible to participate in the boxing competition of the Olympic Games Paris 2024, athletes must be born between and including 1 January 1984 and 31 December 2005.

### C.3. Additional eligibility criteria

Athletes must also comply with the following eligibility criteria:

- I. Adhere to the Paris 2024 Boxing Unit Event Regulations (found [here](#)), including all competition and Anti-Doping provisions.
- II. Participate in at least one (1) of the boxing qualification tournaments for the Olympic Games Paris 2024.

## D. QUALIFICATION PATHWAY

### D.1. QUOTA PLACES

The Olympic qualification period will run from 01 May 2023 to (and including) 31 May 2024.

**Women's Events:** Six (6) events-weight categories will feature in the Olympic Games Paris 2024. The quota places distribution will be as such:

### Qualification Pathway

Athletes will be allocated a quota place on the basis of:

- Their ranking in their respective continental qualification tournament;
- Their ranking in the 1<sup>st</sup> World Qualification Tournament (WQT);
- Their ranking in the 2<sup>nd</sup> WQT;
- Host Country places;
- Universality places.

## D.2. HOST COUNTRY QUOTA PLACES

The Host Country will be guaranteed a maximum **six (6)** quota places, three (3) for Women and three (3) for Men, provided that the athlete eligibility criteria in Section C are respected.

After the completion of the respective continental qualification tournament, the Host Country will be asked to confirm any quota places allocated to them via this tournament. The Host Country quota places will be recalculated by deducting any confirmed quota places obtained through the respective continental qualification tournament.

After the completion of the 1<sup>st</sup> WQT, the Host Country will be asked to confirm any quota places allocated to it via this tournament. The Host Country quota places will be recalculated by deducting any confirmed quota places obtained through the 1<sup>st</sup> WQT.



In order to reach the above-stated guaranteed minimum quota places, the total number of Host Country Places that can be allocated following the 1<sup>st</sup> WQT are as follows:

- If the Host Country does not obtain male quota places through the process as described in paragraph D.1., a total of three (3) male Host Country places can be selected respecting the maximum event specific quota.
- If the Host Country obtains one (1) male quota place through the process as described in paragraph D.1., a total of two (2) male Host Country places can be selected respecting the maximum event specific quota.
- If the Host Country obtains two (2) male quota places through the process as described in paragraph D.1., a total of one (1) male Host Country place can be selected respecting the maximum event specific quota.
- If the Host Country obtains three (3) or more male quota places through the process as described in paragraph D.1., no male Host Country places will be allocated.
- If the Host Country does not obtain female quota places through the process as described in paragraph D.1., a total of three (3) female Host Country places can be selected respecting the maximum event specific quota.
- If the Host Country obtains one (1) female quota place through the process as described in paragraph D.1., a total of two (2) female Host Country places can be selected respecting the maximum event specific quota.
- If the Host Country obtains two (2) female quota places through the process as described in paragraph D.1., a total of one (1) female Host Country place can be selected respecting the maximum event specific quota.
- If the Host Country obtains three (3) or more female quota places through the process as described in paragraph D.1., no male Host Country places will be allocated.

Refer to tables 1 and 2 for the weight categories eligible for Host Country quota places.

### D.3. UNIVERSALITY PLACES

Nine (9) Universality places, five (5) for Women and four (4) for Men, are made available to eligible NOCs at the Olympic Games.

On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm on or before 7 June 2024, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

## **E. CONFIRMATION PROCESS FOR QUOTA PLACES**

### **E.1. CONFIRMATION OF QUOTA PLACES**

The IOC will inform the respective NOCs of their allocated quota places within three (3) working days of the conclusion of the respective qualification tournament.

NOCs will then have two (2) weeks to confirm to the IOC if they wish to use the quota places obtained through a continental qualification tournament as detailed in paragraph G. Qualification Timeline.

NOCs will have two (2) week to confirm if they wish to use the quota places obtained through the two World Qualification Tournaments, as detailed in paragraph G. Qualification Timeline.

### **E.2. CONFIRMATION OF HOST COUNTRY QUOTA PLACES**

Further to the conclusion of the 1st WQT, and in case the Host Country obtains less than the three (3) female and three (3) male the guaranteed quota places across any of the weight categories, then the Host Country will need to confirm the athletes and their respective weight categories selected for Host Country Places by the deadline for NOCs to confirm to IOC the use of the quota place obtained at the 1<sup>st</sup> WQT, provided that the athlete eligibility criteria in Section C are respected

## **F. REALLOCATION OF UNUSED QUOTA PLACES**

### **F.1. REALLOCATION OF UNUSED QUOTA PLACES**

If an allocated quota place of an athlete is not confirmed or is declined by the respective NOC, then the quota place will be reallocated to the athlete defeated by the respective athlete in the specific bout of the Qualification tournament that determined the quota place and respecting the criteria outlined in Section C.

In the need of further reallocation of the same quota, the above procedure is repeated at the respective qualification tournament where the quota place was obtained.

In case no further athlete is available from the respective event, the quota place will be added to the quota of Universality Places, including in weight categories where Universality Places are not pre-determined according to tables 1 and 2 in Paragraph D.1.

In case there are no further eligible athletes as part of the Universality Places, the quota place will be reallocated to the Host NOC subject to the maximum number of athletes per NOC, and provided that athlete eligibility criteria in Section C are satisfied.



## F.2. REALLOCATION OF UNUSED HOST COUNTRY QUOTA PLACES

Any unused Host Country place(s) declined or not confirmed by the confirmation of quota places deadline will be added on to the quota allocation pool of the 2<sup>nd</sup> WQT, in the respective weight category.

Any unused Host Country place(s), declined past the confirmation of quota places deadline relative to the 2<sup>nd</sup> WQT will not be reallocated.

## F.3. REALLOCATION OF UNUSED UNIVERSALITY PLACES

Any unused Universality Place(s), declined or not confirmed by the confirmation of quota places deadline will be reallocated according to Section 2B. Invitation Places subject to the principle of reallocation of unused quota places in the “*Games of the XXXIII Olympiad, Paris 2024 Olympic Games Tripartite Commission Universality Places - Allocation Procedure and Regulations*”
