NOCs may obtain a maximum of three (3) quota places per event in case they are represented by a minimum of three (3) athletes within the highest 30 places of the World Triathlon Individual Olympic Qualification Ranking [here](#) as of 27 May 2024. Other NOCs may obtain a maximum of two (2) quota places per event.

NOCs with two (2) men and two (2) women qualified, irrelevant to the qualification pathway, are entitled to have a team competing in the mixed relay event.

###### B.3. Type of allocation of quota places:

Quota places are allocated to the NOC(s).



## C. ATHLETE ELIGIBILITY

### C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of World Triathlon, may participate in the Olympic Games Paris 2024.

### C.2. Age requirements

To be eligible to participate in the individual events, athletes must be born on or before 31 December 2006. To be eligible to participate in the mixed relay event, athletes must be born on or before 31 December 2009.

### C.3. Additional IF eligibility criteria

To be eligible to participate in the Paris 2024 Olympic Games, all athletes must represent the same National Federation during the whole qualification period and meet one of the following requirements by 27 May 2024:

- To qualify via the 2022 World Triathlon Mixed Relay Championships, the 2023 World Triathlon Mixed Relay Championships, the World Triathlon Mixed Relay Olympic Qualification Ranking, the World Triathlon Mixed Relay Qualification Event or the World Triathlon Individual Olympic Qualification Ranking, athletes, including those of the host country, must be among the top 140 in the World Triathlon Individual Olympic Qualification Ranking.
- To qualify via the World Triathlon Ranking, athletes, including those who are allocated a Universality place, must be among the top 180 in the World Triathlon Ranking.

## D. QUALIFICATION PATHWAY

### D.1. QUOTA PLACES

The qualification events are listed in hierarchical order of qualification. The full World Triathlon calendar of events can be found [here](#).

Athletes who comply with the age requirements outlined in section **C. Athlete Eligibility** are eligible for both individual and mixed relay events.



## D.2. QUALIFICATION VIA MIXED RELAY EVENTS

2	<b>2022 World Triathlon Mixed Relay Championships, Montreal/Canada, 26 June 2022</b> <p>The highest ranked NOC in the 2022 World Triathlon Mixed Relay Championships will be allocated two (2) quota places per gender. In case the NOC already obtained the quotas, then the quota places will be allocated to the next highest ranked eligible NOC in the event. In case the NOC doesn't have two men and two women eligible, the places will be allocated to the next highest ranked eligible NOC in the event.</p>
2	<b>2023 World Triathlon Mixed Relay Championships, Hamburg/Germany, 16 July 2023</b> <p>The highest ranked NOC in the 2023 World Triathlon Mixed Relay Championships will be allocated two (2) quota places per gender. In case the NOC already obtained the quotas, the quota places will be allocated to the next highest ranked eligible NOC in the event. In case the NOC doesn't have two men and two women eligible, the places will be allocated to the next ranked eligible NOC in the event.</p>
12	<b>World Triathlon Mixed Relay Olympic Qualification Ranking</b> <p>The six (6) highest ranked NOCs on the World Triathlon Mixed Relay Olympic Qualification Ranking as of 25 March 2024 will be allocated two (2) quota places per gender. In case an NOC already obtained the quotas, the quota places will be allocated to the next highest ranked eligible NOC in the ranking. In case an NOC doesn't have two men and two women eligible, the places will be allocated to the next highest ranked NOC. If there is no NOC with two men and two women eligible, the places will be allocated to the World Triathlon Individual Olympic Ranking. The events counting for the World Triathlon Mixed Relay Olympic Qualification Ranking will be according to the criteria outlined on the official website of World Triathlon <a href="#">here</a>.</p>
4	<b>2024 World Triathlon Mixed Relay Olympic Qualification Event, Huatulco/Mexico, 17 May 2024</b> <p>The two (2) highest ranked NOCs from the World Triathlon Mixed Relay Olympic Qualification Event will be allocated two (2) quota places per gender. In case an NOC has already obtained the quotas, they will not be eligible to participate in the 2024 World Triathlon Mixed Relay Qualification Event. In case an NOC doesn't have two men and two women eligible, the places will be allocated to the next highest ranked eligible NOC in the event, if there is none, the places will be allocated to the next highest NOC in the World Triathlon Mixed Relay Olympic Qualification Ranking.</p>



### D.3. QUALIFICATION VIA INDIVIDUAL EVENTS

26	<p><b>World Triathlon Individual Olympic Qualification Ranking - between 27 May 2022 and 27 May 2024</b></p> <p>The 26 highest ranked athletes on the World Triathlon Individual Olympic Qualification Ranking as of 27 May 2024 will be allocated one (1) quota place for their NOC, respecting the maximum quota allocation per NOC per event. In case the NOC already obtained the quotas, they will not be allocated these quota places. The events counting for the World Triathlon Individual Olympic Qualification Ranking will be according to the criteria outlined on the official website of World Triathlon <a href="#">here</a>.</p>
2	<p><b>Universality places</b></p> <p>Two (2) quota places per gender will be allocated by the Tripartite Commission. The International Olympic Committee will invite all eligible NOCs to submit their requests for Universality places. If the Tripartite Commission is not able to allocate a Universality place, it will be reallocated to the next highest ranked NOC, according to the World Triathlon Individual Olympic Qualification Ranking.</p>
5	<p><b>World Triathlon Ranking as of 27 May 2024</b></p> <p>In order to ensure continental representation, the highest ranked NOC not yet qualified will obtain one (1) quota place for their NOC.</p> <p>The allocation is done in the following priority order:</p> <ol style="list-style-type: none"><li>1. Africa</li><li>2. Americas</li><li>3. Asia</li><li>4. Europe</li><li>5. Oceania</li></ol> <p>If there is no eligible NOC according to the World Triathlon Ranking for a particular continent, the quota place will be allocated to the NOC of the next highest ranked eligible athlete according to the World Triathlon Individual Olympic Qualification Ranking, irrespective of the continent. Athletes obtaining a quota place through World Triathlon Ranking will remain as eligible in the World Triathlon Individual Olympic Qualification Ranking. In the case that this athlete or any other from the same NOC obtains a quota place through the World Triathlon Individual Olympic Qualification Ranking, the quota place obtained through the World Triathlon Ranking will be cancelled and reallocated through the World Triathlon Ranking to the next highest NOC from the specific continent and not yet qualified. The events counting for the World Triathlon Ranking will be according to the criteria outlined on the official website of World Triathlon <a href="#">here</a>.</p>



#### D.4. HOST COUNTRY PLACES

The host country is guaranteed two (2) quota places per gender provided that they comply with the eligibility criteria outlined in section **C. Athlete Eligibility** above. If there are less than two (2) eligible athletes in any of the genders, those unused quota places will be allocated through the World Triathlon Individual Olympic Qualification Ranking.

#### D.5. UNIVERSALITY PLACES

Two (2) Universality places per gender are made available to eligible NOCs at the Olympic Games Paris 2024.

On 1 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024. The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality places is contained in the “*Games of the XXXIII Olympiad, Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations*” document.

If the Tripartite Commission is not able to allocate a Universality place, it will be reallocated to the next highest ranked eligible NOC, according to the World Triathlon Individual Olympic Qualification Ranking.

### E. CONFIRMATION PROCESS FOR QUOTA PLACES

#### E.1. CONFIRMATION OF QUOTA PLACES

Following the last event of the qualification period, World Triathlon will publish the results on its [website](#).

World Triathlon will inform the respective NOCs of their allocated quota places within seven (7) days of the end of the qualification period.

The NOCs will then have two (2) weeks to confirm in writing or via an attached letter to an email, if they wish to use these quota places, as detailed in paragraph **G. Qualification Timeline**.

#### E.2. CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing or via an attached letter to an email to World Triathlon by 17 June 2024 the use of its host country places.



## F. REALLOCATION OF UNUSED QUOTA PLACES

### F.1. REALLOCATION OF UNUSED QUOTA PLACES

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated as follows:

- Unused quota place from the 2022 World Triathlon Mixed Relay Championships, the 2023 World Triathlon Mixed Relay Championships, the World Triathlon Mixed Relay Olympic Qualification Ranking, World Triathlon Mixed Relay Olympic Qualification Event and World Triathlon Individual Olympic Qualification Ranking will be reallocated to the next highest ranked eligible NOC, according to World Triathlon Individual Olympic Qualification Ranking, respecting the maximum number of athletes per NOC specified in paragraph **B. Quota Places**.
- Unused quota place from the World Triathlon Ranking will be reallocated to the NOC of the next highest ranked athlete from the respective continent that has not obtained a qualification quota according to the World Triathlon Ranking. If there is no eligible NOC from the respective continent, the quota place will be reallocated to the NOC of the next highest ranked eligible athlete according to the World Triathlon Individual Olympic Qualification Ranking, regardless of the continent, respecting the maximum number of athletes per NOC specified in paragraph **B. Quota Places**. Athletes obtaining a quota place through World Triathlon Ranking will remain as eligible in the World Triathlon Individual Olympic Qualification Ranking. In the case that this athlete or any other from the same NOC obtains a quota place through the World Triathlon Individual Olympic Qualification Ranking, the quota place obtained through the World Triathlon Ranking will be cancelled and reallocated through the World Triathlon Ranking to the next highest NOC from the specific continent and not yet qualified.

### F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

Any unused host country place will be reallocated to the next highest ranked eligible NOC, according to the World Triathlon Individual Olympic Qualification Ranking, respecting the maximum number of athletes per NOC specified in paragraph **B. Quota Places**.

### F.3. REALLOCATION OF UNUSED UNIVERSALITY PLACES

Unused Universality place(s) will be reallocated to the next highest ranked eligible NOC, according to the World Triathlon Individual Olympic Qualification Ranking, respecting the maximum number of athletes per NOC specified in paragraph **B. Quota Places**.
