B.4. Type of allocation of quota places:

Quota places are allocated to the athlete(s) by name.

If an NOC has more than three (3) athletes in one gender who are eligible to receive quota places, then the NOC will decide which of these athletes will receive the quota places, respecting the maximum number of athletes per NOC per event.

Host country quota places are allocated to the NOC for eligible athletes.

Universality quota places are allocated to the eligible athlete by name.

C. ATHLETE ELIGIBILITY

C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the conditions of participation established by the IOC, plus the rules of IWF, including the current IWF Anti-Doping Rules (IWF ADR), may participate in the Olympic Games Paris 2024.

C.2. Age requirements

To be eligible to participate in the Olympic Games Paris 2024, athletes must be born on or before 31 December 2009.

C.3. Additional IF eligibility criteria

To be eligible, an athlete shall meet the following criteria:

1) Mandatory event participation

Only IWF Events where the eligible IWF Member Federations / NOCs can participate with the maximum number of athletes per article 1.2.7 of the IWF TCRR can qualify as qualification events.

a) An Athlete must participate in the following events:

i. Compulsory Events

- 2023 IWF World (Senior) Championships (Riyadh, KSA) / 4 17 September 2023
- 2024 IWF World Cup (Phuket, THA) / 31 March 11 April 2024

Other than for the purposes of universality quota places, participation in both of these events is <u>compulsory</u>; if an athlete fails to participate in any of these two events, he/she shall not be eligible to participate at the Olympic Games Paris 2024, except in truly exceptional circumstances.





Such would require an extraordinary objective (physical or other) impossibility to attend a "Compulsory Event" (for example attending the competition was impossible due to travel restrictions). The regime of exceptional circumstances shall be strictly applied, in view of the overall objective of the rule. Whether exceptional circumstances are present will be reviewed and decided by a commission of five (5) persons appointed by the IWF Executive Board, composed of three persons recommended by the International Testing Agency (ITA), chair of the IWF Technical Committee and chair of the IWF Medical Committee (without voting rights). Rules governing the procedure before the commission shall be issued by the IWF Executive Board. Any application for exemption based on exceptional circumstances shall be filed with the IWF Secretariat as soon as possible from the moment the exceptional circumstances have become known, and at the very latest within five (5) days from the last competition day of the "Compulsory Event" in which the Athlete did not participate. Exception might be granted only once per Athlete. The decision of the Commission shall be deemed final with no recourse to appeal. Please note that this procedure does not apply to "Additional Events".

ii. Additional Event

Other than for the purposes of host country quota places and universality quota places, participation in a minimum of three (3) of the following events:

- 2022 IWF World (Senior) Championships (Bogotá, COL) / 5-16 December 2022
- 2023 Continental (Senior) Championships or Continental (Senior) Games (one per Continent as officially approved by IWF as a qualification event)
 - 2023 Pan-American (Senior) Championships (Bariloche, ARG) /25 March 2
 April 2023
 - 2023 European (Senior) Championships (Yerevan, ARM) / 15 23 April 2023
 - 2023 Asian (Senior) Championships (Jinju, KOR) / 3 13 May 2023
 - 2023 African (Senior) Championships (Tunis, TUN) / 11 20 May 2023
 - 2023 Pacific Games & Oceania (Senior) Championships / (Honiara, SOL) 20 –
 24 November 2023
- 2023 IWF Grand Prix I (Havana, CUB) / 8 18 June 2023
- 2023 IWF Grand Prix II (Doha, QAT) / 4 14 December 2023
- 2024 Continental (Senior) Championships
 - 2024 African (Senior) Championships (Cairo, EGY) / 2 10 February 2024
 - 2024 Asian (Senior) Championships (Tashkent, UZB) / 3 10 February 2024

- b) For host country places, athletes must participate in the two compulsory events of Section C.3.1.a.i, and at least at two of the events of Section C.3.1.a.ii..
- c) For Universality places, athletes must participate in at least two of any of the events listed in Section C.3.1.a.i. and C.3.1.a.ii..
- d) Participation for the purposes of the above means, at a minimum, attending, weighing-in, and participating in the official introduction of athletes (as per IWF Technical and Competition Rules & Regulations section 6.5). For the avoidance of doubt, participation does not require competing at the event.





- e) The criteria of participation can be achieved in any bodyweight category (Olympic or non-Olympic).
- f) With reference to article 5.5.16 of the IWF ADR, the list of Athletes set to participate in any of the qualification events above (and the related whereabouts information per this provision) must be submitted at minimum three (3) months prior to the qualification event in question. For the avoidance of doubt, in case of non-compliance, the consequences outlined in Article 5.5.13 of the IWF ADR are applicable.
- g) The International Testing Agency (ITA) will plan and execute a robust In- and Out-of-Competition Test Distribution Plan, driven by an ISTI-compliant risk assessment, which includes, but is not limited to, increased focus on countries with a history of doping.

2) Mandatory Education

a) Every Athlete must complete the E-learning Course for Registered Testing Pool Athletes on the WADA ADEL platform (<u>Anti-Doping Education and Learning</u>) as mandatory education in order to be eligible to receive quota place. Each NOC/Member Federation shall ensure that the program is duly completed by their Athletes and shall have the responsibility to provide the IWF with a certificate demonstrating the completion of the programme by 28 April 2024 at the latest and inform the NOC accordingly.

Consequences due to Anti-Doping Rule Violations

Without prejudice to the power of the Independent Panel per article 12.1 IWF ADR (the "Independent Panel") to impose any other consequences, such as Member Consequences, under article 12 IWF ADR, the following provisions shall apply:

- a) In the event that during the period from 23 July 2021 until 25 July 2024 a Member Federation (MF) is found to have breached an obligation under the IWF ADR, including, without limitation, under Article 18 (but excluding the violations under Article 12), or failed to comply with any directive or request on anti-doping matters issued by the IWF, the Independent Panel may withdraw some or all of the quota place(s) from that MF/NOC with regard to the Olympic Games Paris 2024 or the next ensuing Olympic Games.
- b) Should three (3) or more Anti-Doping Rule Violations sanctioned by IWF or Anti-Doping Organisations other than a Member Federation or its National Anti-Doping Organisation have been committed by Athletes and/or other Persons affiliated to such MF/NOC from 23 July 2021 until 25 July 2024, the Independent Panel may withdraw some or all of the quota place(s) from that MF/NOC with regard to the Olympic Games Paris 2024 or the next ensuing Olympic Games.¹ In cases where three or more of the underlying violations involve periods of Ineligibility of four years or more, all quota places shall be withdrawn.
- c) When considering the application of point a) and b) above, the Independent Panel may refer to the principles set forth in Article 12.3.2 and 12.4 IWF ADR applicable to the imposition of Member Consequences. Similarly, the procedural rules of Article 12.7 of the IWF ADR apply by analogy to the process pertaining to the provisions above.

¹ Quota reduction with respect to the next ensuing Olympic Games may be justified eg. where the third Anti-Doping Rule Violation is only reported after the Olympic Games Paris 2024.





- d) Any quota places withdrawn pursuant to point a) and/or b) above shall be reallocated in accordance with the reallocation process as detailed in section **F. Reallocation of Unused Places.**
- e) With reference to Article 12.3.3 IWF ADR, should two or more Athletes or other Persons affiliated to an MF/NOC be found to have committed an Anti-Doping Rule Violation giving rise to a period of ineligibility of four years or more on the occasion of the Olympic Games Paris 2024 (including following further analyses of samples), the concerned MF/NOC shall be automatically prevented from recommending, entering and/or proposing affiliated Athletes or other Persons for participation in the next ensuing Olympic Games following the final decision imposing the (first two) relevant sanctions (and shall take all necessary measures to prevent such participation), without prejudice to any other sanction that may be imposed in accordance with the IWF ADR.

D. QUALIFICATION PATHWAY

D.1. QUOTA PLACES

- At maximum, one (1) athlete per NOC shall be ranked on the OQR, which would be the highest ranked athlete per NOC, in each bodyweight category to be contested at Olympic Games Paris 2024.
- In the circumstance that two, or more, athletes record the same Total in the same
 Olympic bodyweight category they shall be ranked in order of which achieved the
 result first, using equivalent Greenwich Mean Times (GMT) to decide such if
 necessary.

Following the end of the qualification period the highest OQR ranked ten (10) athletes in each event to be contested at Olympic Games Paris 2024 will be allocated a quota place.

- If an athlete is ranked in the top 10 in more than one event in the OQR, then that athlete's NOC in consultation with the Member Federation (MF), as recognised by the IWF, must declare to the IWF by 6 May 2024 in which event that athlete will compete in Olympic Games Paris 2024, and the athlete will then be removed from the OQR in other bodyweight categories. Any freed ranking position due to declaration of competing in another event will then automatically move to the next highest ranked eligible athlete.
- Should an NOC record more than three (3) athletes per gender from different weight categories in the OQR then the relevant NOC in consultation with the MF must declare to the IWF by 15 May 2024 which of these athletes shall be allotted the quota





| | places. Any athletes not so declared will then be removed from the OQR. Any declined ranking positions and quota places will then automatically move to the next highest ranked eligible athlete from an NOC which has not used its three quota places. The qualification period for the OQR shall begin on 01 August 2022 and conclude on 28 April 2024. |

D.2. HOST COUNTRY PLACES

The host country is guaranteed four (4) quota places in total, two (2) for men and two (2) for women.

If the host country would qualify with two (2) or less athletes per gender, the host country places will be used.

Athletes from the host country may obtain the maximum number of quota places through the OQR as any other athlete from any other NOC, in case they qualify with three (3) athletes per gender.

In case the host country will obtain three (3) quota places per gender the quota places will obtain from the OQR and not from the host country places.

If the host country qualifies three (3) athletes (same gender), the IWF selects the two (2) bodyweight categories for the reallocation of unused host country places from the three (3) bodyweight categories where the athletes qualified.

D.3. UNIVERSALITY PLACES

Six (6), three (3) Men and three (3) Women, Universality places are made available to eligible NOCs at the Olympic Games Olympic Games Paris 2024.

On 01 October 2023, the International Olympic Committee (IOC) will invite all eligible NOCs to submit their requests for Universality places. The deadline for NOCs to submit their requests is 15 January 2024.





The Tripartite Commission will confirm, in writing, the allocation of Universality places to the relevant NOCs after the end of the qualification period for the sport concerned.

Detailed information on Universality places is contained in the "Games of the XXXIII Olympiad, Olympic Games Paris 2024 - Olympic Games Universality Places - Allocation Procedure and Regulations" document.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

E.1. CONFIRMATION OF QUOTA PLACES

The IWF will publish the final Qualification Ranking lists by 24 May 2024 on its website.

The IWF will confirm in writing to the NOCs by 24 May 2024 the quota places they have obtained. The NOCs confirm to the IWF by 31 May 2024 if they wish to use these quota places, as detailed in section **G. Qualification Timeline**.

E.2. CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing to the IWF by 12 June 2024 the use of host country places.

F. REALLOCATION OF UNUSED QUOTA PLACES

F.1. REALLOCATION OF UNUSED QUOTA PLACES

If an allocated quota place obtained through the OQR is not confirmed by the NOC by the confirmation of quota place deadline 31 May 2024, or is declined by the NOC, or is withdrawn by the Independent Panel, the quota place will be reallocated to the next highest-ranked eligible athlete of the same weight category on the OQR, respecting the maximum quota per gender and per NOC.

If an allocated quota place obtained through the Continental representation is not confirmed by the NOC by the confirmation of quota place deadline 31 May 2024, or is declined by the NOC, or is withdrawn by the Independent Panel, the quota place will be reallocated to the next highest-ranked eligible athlete of the same weight category from a Continent not yet represented, respecting the maximum quota per gender and per NOC.

If all five continents are represented in the bodyweight category, the Continental quota place will be reallocated to the next highest-ranked eligible athlete of the same weight category (regardless of the Continent), respecting the maximum quota per gender and per NOC.





F.2. REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused host country place(s) will be reallocated to the next highest-ranked eligible athlete in the OQR of the same weight category, respecting the maximum quota per gender and per NOC.

F.3. REALLOCATION OF UNUSED UNIVERSALITY PLACES

Any unused Universality place(s) will be reallocated to the next highest-ranked eligible athlete of the same weight category in the OQR and respecting the maximum quota per gender and per NOC. The process will be repeated until the quota has been filled for each category.
