6)	Rights-Holder provides the following verification and attaches hereto supporting documents of Rights-Holder's cease & desist letter and/or notice under the Digital Millennium Copyright Act notifying the website operator that it is engaging in infringing activity, or an attestation that, to the best of the Rights-Holder's knowledge, the site is not licensed or otherwise authorized to sell the alleged Illegitimate Products in question.

To the extent additional documents are attached to this Notice Form in fulfillment of the submission requirements, Rights-Holder identifies and summarizes the attached documents in the relevant sections above.

Rights-Holder agrees to provide a prompt response to any communication from American Express or its attorneys for additional information relevant to an investigation of the allegations made herein.

Upon receipt of a complete Notice Form, American Express will conduct, or request that the applicable merchant acquirer conduct, an investigation. A general summary of the results of the investigation will be provided to the Rights-Holder.

If the investigation demonstrates that the merchant is engaged in sales of Illegitimate Products, American Express will demand, or request that the applicable merchant acquirer demand, that the merchant immediately cease such sales and prevent future improper transactions using American Express Cards. If a merchant persists in intentionally and systematically selling Illegitimate Products, American Express may, in its sole discretion, suspend or terminate, or request that the applicable merchant acquirer suspend or terminate, American Express Card services to that merchant.

Rights-Holder understands that submission of this Notice Form may result in the temporary or permanent restriction of an American Express Merchant Account associated with the identified URL and has exercised sufficient due diligence in investigating the alleged sale of Illegitimate Products on the website at issue before submitting this Notice Form.

Rights-Holder understands that American Express may request a written agreement by the Rights-Holder to support American Express fully in connection with a dispute where, in American Express' reasonable opinion, a merchant provides credible evidence supportive of the merchant's position that it is not engaged in illegal conduct, including by defending, holding harmless and indemnifying American Express for any costs, expenses (including legal fees) or liabilities arising in connection with such dispute.

Rights-Holder attests that the information in this Notice Form is accurate and complete, and requests that American Express conduct an investigation into the allegations made herein.
