CareSource would like to remind providers that Ohio Department of Medicaid (ODM) is kicking off its provider awareness and training efforts in preparation for the October 1, 2022, Stage 2 launch of the Next Generation program.

To begin these efforts, ODM will be hosting a 2-hour webinar to share information on the exciting changes Ohio Medicaid providers can expect, including an overview on the transition to the Ohio Medicaid Enterprise System (OMES) modules, upcoming training plans and dates, and where providers can receive communications from ODM throughout the Next Generation transition and implementation.
