### on the Implementing Rules of the High Level Traineeship Programme in the Delegations of the European Union in Partnership with the Member States of the European Union

THE DIRECTOR-GENERAL FOR RESOURCE MANAGEMENT OF THE EUROPEAN EXTERNAL ACTION SERVICE, IN AGREEMENT WITH THE DIRECTORS-GENERAL OF DG INTPA AND DG HR OF THE EUROPEAN COMMISSION,

Having regard to Decision JOIN(2017)22 of the European Commission and the High Representative of the Union for Foreign Affairs and Security Policy of 19.6.2017 amending the Joint Decision of the Commission and the High Representative of the Union for Foreign Affairs and Security Policy of 12.06.2012 establishing a High Level Traineeship Programme in the Delegations of the European Union in Partnership with the Member States of the European Union (JOIN(2012)17 final),

Having regard to the Decision of 22 January 2014 of the Chief Operating Officer of the EEAS in agreement with the Directors-General of DG INTPA and DG HR of the European Commission (EEAS DEC(2014)002) amended by the Decision ADMIN(2017)8 of 21 June 2017, Decision ADMIN(2019) 13 of 27 May 2019, Decision ADMIN(2021) 14 of 13 April 2021, Decision ADMIN(2021) 14 REV1 of 29 November 2021,

Whereas:

- (1) Article 2(4) of the Joint Decision ADMIN(2017)8 of 21 June 2017 stipulates that a biennial adjustment of the amount of the grant and contributions allowed is decided based on the annual update of the remunerations of the officials of the EU;
- (2) The European Commission published in the Official Journal of the European Union the annual adjustments with effect on 1<sup>st</sup> July 2021<sup>1</sup> (+ 1.9 %) and on 1<sup>st</sup> January 2022<sup>2</sup> (+ 2,4 %);
- (3) Due to the rapid inflation across the world, the cost of living has significantly increased;

## Article 1

The Annex of the Decision EEAS DEC(2014)002 of 22 January 2014 is amended as follows:

1. Point 5.1, the amount of the monthly basic grant is set at **1,521 EUR**<sup>3</sup> (one thousand five hundred twenty-one euro).
2. Point 5.2, the amounts of the contributions are set out as following:
  - the monthly accommodation contribution:  
**1,171 EUR** (one thousand one hundred seventy-one euro).
  - the installation contribution:  
**2,340 EUR** (two thousand three hundred forty euro).
  - the contribution towards the cost of the journey:  
**2,926 EUR** (two thousand nine hundred twenty-six euro).

## Article 2 – Date of taking effect and application

This Decision shall take effect on the date of its adoption and shall be applicable to the Round 2021-2023 of Traineeships as from 16/09/2022, start date of the 2<sup>nd</sup> year of traineeship.
