| <b>Why?</b>  | Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.  |
| <b>What?</b> | The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>■ Social Security number, DOB, income, and other personal information</li> <li>■ Credit history and credit scores</li> <li>■ Monthly payment amounts, account balances, and payment history</li> </ul> |
| <b>How?</b>  | All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons <b>JetStream Lending Company, LLC</b> chooses to share; and whether you can limit this sharing.  |

## What we do

### How does JetStream lending Company, LLC protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law, as do any company we partner with. These measures include computer safeguards and secured files and buildings. Only authorized employees are allowed to access your information.

### How does JetStream lending Company, LLC collect my personal information?

We collect your personal information, for example, when you

- apply for a loan,
- provide account information, or show your drivers license
- provide employment information, give us your income information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies such as the IRS, appraisers, employers, and government sources.

### Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

### What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account—unless you tell us otherwise.

## Definitions

### Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

JetStream lending Company, LLC has no affiliates

### Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- We do not share with non-affiliates to market to you.

### Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- We do not jointly market to you.
