Intergovernmental Process for the Declaration on Future Generations

Presentation of the Zero Draft

Excellency,

Reference is made to the letter of the Co-Facilitators of the intergovernmental process for the Declaration on Future Generations, dated 27th February 2024, in which we indicated our intention to share the zero draft of the Declaration by the 26th March, in advance of intergovernmental negotiations to be held between April and June 2024.

The inputs from Member States received in February 2024 form the basis for the zero draft of the Declaration on Future Generations, which you will find annexed to this letter.

We believe that this zero draft text stands as a well-balanced foundation for our intergovernmental negotiations. Our ultimate goal is to collectively adopt an ambitious, future-proof, and action-oriented Declaration on Future Generations as an annex to the Pact for the Future, at the Summit of the Future on 22-23 September 2024.

Taking into consideration the concerns of Member States expressed during the informal briefings with UN regional groups, we shall commence the intergovernmental process with a presentation by the Co-Facilitators of the zero draft of the Declaration on Future Generations on 8 April 2024. Member States will have the opportunity to make brief general comments at this meeting. Subsequently, Member States will be invited to submit any written inputs by 19 April 2024.

In light of this, an updated roadmap for the process is outlined below:


