Excellency,

Reference is made to the letter of the Co-Facilitators of the intergovernmental process for the Declaration on Future Generations, dated 3 May 2024, with which we transmitted the compilation of written inputs to the zero draft submitted by Member States and Observers on 19 April 2024.

We take this opportunity to express our gratitude to all delegations for their active engagement in the first reading of the zero draft of the Declaration on Future Generations, held on 14 and 17 May, with the compilation document as a resource. The collaborative spirit and constructive feedback received underscore our shared dedication to creating a sustainable and inclusive future for all.

Annexed to this letter, you will find the REV1 of the Declaration on Future Generations, which has been carefully crafted to reflect the collective insights, written inputs, general comments, and interventions made by Member States to date. We believe that this revised text successfully addresses the needs and interests of future generations while reflecting the priorities and actions envisioned by Member States.

Additionally, you will find an Explanatory Note indicating our working methodology in progressing from the zero draft to this REV1. This revised version builds upon the foundational principles and objectives established in the zero draft, incorporating valuable contributions from Member States and Observers.

The second reading of the Declaration on Future Generations will be held on 10 June 2024, from 10:00AM to 1:00PM in CR2, and will take place based on the annexed REV1. We will take a paragraph-by-paragraph approach to negotiating the text, with Member States and Observers limited to two (2) minutes per intervention, per paragraph. Interventions made on behalf of groups will be limited to four (4) minutes.

Should time constraints prevent the completion of all paragraphs on 10 June 2024, we shall consider the possibility of continuing the second reading on 14 June 2024. We will ensure that this additional session does not overlap with other processes within the Summit of the Future.


In light of this, an updated roadmap for the remainder of the process is outlined below:
