The Chairperson reminded the delegates that the ballot will be held on 15 November 2023 and that the deadline for any change or submission of candidatures was on Monday 13 November 2023 at 9:00 a.m. (according to Appendix 2 of Rule 4 of the Rules of Procedure of the General Conference).

4. The Nominations Committee then considered items 12.2 to 12.16 Elections of Headquarters Committee, Legal Committee and other subsidiary organs of the General Conference and appointment of an External Auditor; and reviewed candidatures received as of Tuesday 7 November 2023 (1:00 p.m.)

The Chairperson reminded the delegates that the ballot will be held on Thursday 16 November 2023 and that deadline for the submission of candidatures was on Thursday 9 November 2023 10:00 a.m. (according to Appendix 1 of Rule 3(a) of the Rules of Procedure of the General Conference).

6. The Nominations Committee took note of additional candidatures submitted and corrections made from the floor (South Africa for SC Vice-chairperson, Lebanon and Saint

Lucia for Tellers; France), recalling that all nominations should reach the Secretariat in writing.
7. Concerning agenda items 12.2 to 12.16 Elections Headquarters Committee, Legal Committee, and other subsidiary organs of the General Conference, and appointment of an External Auditor, examination, and accurate follow-up by Member States of the status of candidatures, contained in document 42 C/NOM/INF.2 (status as of Tuesday 7 November 2023 at 1 p.m.) were held.
8. The Chairperson informed that the updated list of candidatures for the subsidiary organs of the General Conference will be available on Friday 10 November in document 42C/NOM/INF.2 Rev., containing all the candidatures received by Thursday 9 November 2023 at 1 p.m.
