These determinations are binding on a holder of the New Notes unless the holder explicitly discloses that its determination is different from Verizon's determination on the holder's timely filed federal income tax return for the taxable year that includes its acquisition date of the New Notes, in accordance with the requirements of the regulations.

- The New Notes (CUSIP Numbers 92343VEQ3 and U9221ABK3) are "traded on an established market" within the meaning of U.S. Treasury Regulation section 1.1273-2.
